



# Safe Driving and Carrier Safety Awards

# Eligibility Criteria - Drivers

A Safe Driving Award is available to the top three drivers of commercial vehicles 11,000 kg.\* and over, in each of the following five categories:

- · Rig moving
- · Pumping services
- Wireline services
- Fire, shower and safety services (\*5000 kg. and over)
- · General petroleum industry hauling

Companies may nominate drivers in each of the categories, based on the total number of employees in their employ as follows:

- 1 100 employees: 1 nomination
- 1 nomination for every 100 employees over the first 100

To be eligible for nomination for a Safe Driving Award, a driver must:

- Be employed by a PSAC member company
- Have a minimum of three continuous years petroleum industry driving experience in the category in which they are nominated
- Have no impaired, careless, dangerous or other driving related Criminal Code convictions
  within the five years immediately preceding their nomination for an Award
  (a driver abstract, dated no earlier than February 1, 2006 must accompany
  the driver's nomination)
- Have zero demerits in the 12 months immediately preceding their nomination for an Award
- Show compliance with the driver's portion of the National Safety Code for two years (no
  incidents or warnings on the driver's or carrier's record due to driver's non-compliance)
  prior to their nomination for an Award

### The driver nomination must include:

- Details of all training received, e.g. GODI, TGC, WHMIS, H2S, etc.
   (copies of current certificates for this training must accompany the driver nomination)
- · Copy of driver's license and abstract

In addition to confirming that a nominee for a Safe Driving Award meets the requirements set out above, the Awards Committee will also consider:

- · Number of "accident free" kilometres
- Number of accidents involving company vehicle(s)

### **PURPOSE**

- To recognize the top petroleum industry transportation drivers, in the categories noted here, for their safe driving records.
- To recognize the top PSAC member companies, in the categories noted here, for their safety records and for their contributions to the promotion of driver and fleet safety in the petroleum industry.
- To increase the public profile of drivers and companies as industry leaders in the field of safety.
- To recognize contributions made to the petroleum industry in the field of driver and fleet safety.
- To provide an incentive to drivers and companies to become industry leaders in the field of driver and fleet safety.

## Eligibility Criteria - Carriers

A total of four Awards are available to PSAC member companies, based on the number of kilometres driven on an annual basis in western Canada (BC, Alberta, Saskatchewan, Manitoba and the Territories), by all of their commercial vehicles (light and heavy), as follows:

- · Under 1 million kilometres
- 1 − 5 million kilometres
- 5 10 million kilometres
- Over 10 million kilometres

### **Companies submitting a Carrier Safety Award application must:**

- Be a PSAC member company in good standing
- Have a minimum of three years in business in the petroleum industry at the time of application
- Provide the following information taken from the Carrier Profile maintained by the jurisdiction(s) in which the carrier operates and covering the period January 1, 2005 to December 31, 2005
  - (a) Safety Fitness Rating
  - (b) Conviction information
  - (c) CVSA Inspection Results
  - (d) Violations
- Submit a release, authorizing Alberta Transporation and any other jurisdiction(s) in which
  the carrier operates, to provide PSAC with a copy of the Carrier Profile
- Insurance "Claims Loss Run"
- Reportable collisions, i.e. collisions involving all commercially registered vehicles over 11,000 kg. and over \$1,000 in damage
- Preventable accident frequency rate based on actual kilometres driven (Partners in Compliance (PIC) standards)

### **ADDITIONAL INFORMATION**

The Awards Committee, in determining eligibility for an Award, may also use the following information, provided it accompanies the Nomination or Application.

#### **Drivers**

- Participation in employer's safety program
- Customer service records
- · Letters of commendation or reference
- Driver's personal insurance records (optional)

### **Carriers**

- Details of programs in place for incident and injury prevention
- · Details of driver training programs
- Details of drug and alcohol policies in place
- Details of Safety Awards/Incentive Programs in place (if any)
- Details of participation in programs such as Partnerships, etc.
- Copy of the Executive Summary of the company's most recent COR external audit
- Programs in place for company vehicle maintenance
- Letters of commendation/reference received from customers
- · Details of participation in PSAC initiatives
- Details of participation in petroleum services transportation safety performance initiatives

### Awards Committee

The PSAC Safe Driving & Carrier Safety Awards Committee is made up of the following members:

- Immediate past Chair of the PSAC Transportation Issues Committee (TIC)
- Three representatives from TIC
- One representative from Alberta Transportation
- Representatives of the Award sponsor(s) maximum of 2
- · One PSAC staff member (non-voting)

PSAC representatives hold the majority vote on the Awards Committee.

## **Applications and Nominations**

Application and nomination forms are sent to all PSAC member companies in January. Forms must be returned to PSAC by no later than February 17, 2006. Nominations will be based on driver and carrier records for the period January 1 to December 31 of the preceding year.

## Announcement of Award Recipients

Awards will be presented at the annual Awards Dinner held during the PSAC Spring Conference in Red Deer, April 11 & 12, 2006.

If, in the opinion of the Awards Committee, there are no drivers or carriers eligible to receive Awards in any particular category, in any given year, the Awards Committee may decide not to make an Award.

The decision of the Awards Committee on all matters related to the Awards is final, with the exception described under Information Validation.

### **INFORMATION VALIDATION**

The PSAC Board of Directors reserves the right to revoke an Award in the event that a driver or carrier knowingly submits false information in support of a nomination or application, or knowingly permits the submission of false information by another party in support of a driver's nomination or a company's application.
