

Application for Permission to Reproduce, Use and Distribute Atlas of Canada Maps or Data

To obtain permission to reproduce, use or distribute maps or data from The Atlas of Canada, the following form, **Permission to Reproduce, Use and Distribute Atlas of Canada Maps or Data**, must be completed and submitted to Natural Resources Canada.

This permission form applies to most common uses of Atlas of Canada maps and data, including the following:

- **use in a Book or Publication**
- **use in an Academic Paper or Thesis**
- **use in a Report, Study, Article or Brochure**
- **use in the Publishing of Maps or Charts**
- **use on a Web Site or in other Multi-media Productions**

Instructions

1. This form must be completed and submitted to the Geomatics for Connecting Canadians program of Natural Resources Canada by e-mail, fax or postal mail. *Note, certain versions of Adobe® Acrobat® will allow you to complete the form within your browser.*
2. You must complete the **Date, Licensee Name, Postal Address, City/Town, Province/State, Country, Postal/Zip Code, and Telephone** fields. The organization name, fax number and e-mail address should be provided if available.
3. You must provide the name of the person, institution, organization, or company on whose behalf you are seeking copyright clearance.
4. In Article 2, you are required to **identify the specific Atlas of Canada maps or data** that you are requesting permission to reproduce.
5. In Article 3, you are required to **specify the end use** for the Atlas of Canada maps or data. If you intend to use Atlas of Canada material for advertising or promotional purposes, you must submit an explanatory letter along with your form.
6. We will not process incomplete and/or unreadable forms.

- 8) The Data is provided on an "as is" basis and NRCan makes no guarantees, representations or warranties respecting the Data, either expressed or implied, arising by law or otherwise, including but not limited to, effectiveness, completeness, accuracy or fitness for a particular purpose.
- 9) NRCan shall not be liable in respect of any claim, demand or action, irrespective of the nature of the cause of the claim, demand or action alleging any loss, injury or damages, direct or indirect, which may result from the Licensees' use or possession of the Data or in any way relating to this Agreement. NRCan shall not be liable in any way for loss of profits or contracts, or any other consequential loss of any kind resulting from any defect in the Data.
- 10) The Licensee shall indemnify and save harmless NRCan and its ministers, employees and agents from and against any claim, demand or action, irrespective of the nature of the cause of the claim, demand or action, alleging loss, costs, expenses, damages or injuries (including injuries resulting in death) arising out of the Licensees' use or possession of the Data.
