Please provide all of the requested information so that we can process the application. If the application indicates that the corporation would benefit from filing an elective return, we will authorize the Canadian payer(s) to reduce the amount of non-resident tax they withhold from the acting income.
- If we approve this application, we assume that the corporation will file an elective return under section 216.1 of the *Income Tax Act* before the deadline for doing so. If the corporation does not file a return by the filing deadline, the CCRA will assess it at a rate of 23% on the gross income earned from acting services in Canada. If the corporation elects to file a return and has paid a related individual actor, the actor also has to file an elective return
- If the corporation elects to file a return, it must report all income earned in Canada during the current tax year on that return, including income listed in section 6 below. Please consult the <u>T2 Corporation Income Tax Guide</u>.
- The reduction in the amount of tax withheld does not apply to non-acting income, such as income from producing or directing. This income must also be reported on the tax return, but it may be eligible for an exemption under a tax treaty between Canada and the country of residence.
