

## **Excise Taxes**

Effective April 1, 2004, all excise tax rulings, licensing requests, and enquiries are centralized within the Excise Duties and Taxes Division at Headquarters. The only exception to this is for the Northern Ontario and Québec Regions, which maintains responsibility for these activities in their respective Regions. Excise tax is currently imposed on following commodities: jewellery, motive fuels, automotive air conditioners, and certain vehicles exceeding a weight threshold.
