COMPLETION OF THE APPLICATION

Please note the following:

- **Each application must be accompanied by a fee of one hundred dollars (\$100.00).** All cheques or money orders must be made payable to the Receiver General for Canada.
- Completed applications and **accompanying payments** may be taken to most Competition Bureau Offices for immediate assignment of an identification number or mailed to the address identified on the application. Applications may also be submitted electronically through the Competition Bureau web site:

Failure to complete the application accurately may delay processing of the application and the assignment of an Identification Number.

Please type or clearly print all required information.

- **Full legal name under which the dealer carries on business in Canada.**

Only one name under which the applicant normally carries on business in Canada should appear on the application.

- **Principal Place of Business or Head Office in Canada.**

A complete and accurate address, that of the principal place of business in Canada or in the case of a corporation its Canadian head office, including street address and postal code must appear on the application. Include current telephone number of Principal Place of Business.

Note: **Notification of change in name and/or address must be made in writing to the nearest Competition Bureau Office.**

- **Canadian Mailing Address.**

A complete and accurate **Canadian** address, sufficient for postal delivery. If applicable, address should include post box number and postal station, general delivery information, rural route number, etc.

- **Name of authorized official and date of application**

Identify the official or authorized contact person responsible for the products to which the identification number will be applied, including responding to consumer inquiries and complaints. The applicant must date the application.
