## Definitions

In this application form, the following words have the following meanings:

**"Alberta Centennial Education Savings Grant"** means a grant payable under the *Alberta Centennial Education Savings Act*, S.A. 2004, c. A-14.7 and under the *Alberta Centennial Education Savings Plan Regulation*, *Alberta Regulation*, 248/2004.

**"beneficiary"** means a person designated by a subscriber, to whom or on whose behalf an educational assistance payment under a Registered Education Savings Plan (RESP) is agreed to be paid if the person qualifies under the RESP.

**"custodial parent/legal guardian"** means the person authorized by or pursuant to the law of Canada or a province to administer the affairs or estate of the beneficiary.

**"educational assistance payment"** means any amount, other than a refund of payments, paid out of an education savings plan to or for an individual to assist the individual to further the individual's education at a post-secondary level.

**"education savings plan"** means a contract made at any time between

- (a) either
  - (i) one individual (other than a trust), or
  - (ii) an individual (other than a trust) and the spouse or interdependent relationship partner of the individual, and
- (b) a person or organization (in this section referred to as a "promoter")

under which the promoter agrees to pay or to cause to be paid educational assistance payment to or for one or more beneficiaries.

**"Registered Education Savings Plan"** as defined in the *Income Tax Act*, R.S.C. 1985, c1.

**"promoter"** means the person or organization who agrees to pay or cause to be paid educational assistance payments to or for one or more beneficiaries.

**"resident of Alberta"** as defined in the *Alberta Centennial Education Savings Plan Act* means a person who is lawfully entitled to be or to remain in Canada and who makes the person's home, and is ordinarily present in Alberta.

**"subscriber/co-subscriber"** means a person who contributes to a Registered Education Savings Plan and has access to the Alberta Centennial Education Savings Grant.

**"trustee"** means a company incorporated under the laws of Canada to carry on in Canada the business of offering to the public its services as trustee.

**These definitions may change based on changes to the *Income Tax Act*, the *Alberta Centennial Education Savings Act* and/or their related regulations.**
