

Preface

This report provides highlights of Canadian agri-food trade in the first nine months of 1998. Emphasis is placed on changes in major trade flows as compared to the same period in 1997. To enhance the understanding of trade flows, information on changes in price and volume indices are provided together with the values of exports and imports.

Part I highlights exports, imports and trade balances for several commodity groups as well as specific products. Major trade flows and important trading partners are identified in this section. Part II includes tables on trade by commodities, groups of products and total trade to all destinations and from all sources. Tables of price and volume indices for all commodity groups are also included.

Particular attention is paid to trade with the United States, as well as the European Union (EU-15), Asia and Latin American countries. The performance of bulk, intermediate and consumer-oriented products is separated.

Please note that the interpretation of these trade data is subject to caution, as they are subject to revision. This is particularly true for current year data, and for some individual commodities such as grains.

Executive Summary

During the first nine months of 1998, Canada's total agri-food exports reached approximately \$15 billion, down 8% compared with the same period in 1997¹. The decline in total exports of agrifood products reflects lower sales values for grains, oilseeds, animal feeds, dried pulses, red meats and other animal products.

At \$4.2 billion, exports of bulk commodities, such as grains and oilseeds, were down 31%. Canada's grain exports (especially wheat) declined 42% to \$2.7 billion. Exports of wheat, other than durum, were down 47% to \$1.6 billion, while durum wheat exports declined to \$750 million, down 10%. Oilseed exports totaled \$1.2 billion, down 2% compared to the same period in 1997. Exports of intermediate agri-food products declined 1% to \$4.1 billion. Canada's exports of consumer-oriented products totaled \$6.5 billion, up 12%. This group of products represented 44% of total agri-food exports.

Canada's total imports of agri-food products reached \$12 billion, up 10%. Imports of bulk commodities totaled \$1.9 billion, up 11%, while imports of intermediate agri-food products rose 7% to \$1.9 billion. At \$8.2 billion, imports of consumer-oriented products rose by 11%.

Although Canada's agri-food trade balance remained positive during the first nine months of 1998 at \$2.9 billion, the value of the agri-food trade surplus was down 45% compared to the same period in 1997. The drop in the value of the trade surplus was especially significant in the bulk sector, down 48% to \$2.3 billion. The trade surplus in intermediate products declined 6% to \$2.3 billion. In addition, the deficit for consumer-oriented trade rose by 6% to \$1.7 billion, in part as a result of the decline in the export value for fresh and frozen pork meats, down 26%.

At \$17 billion, the value of two-way agri-food trade between Canada and the US was up 13%. Exports of Canadian agri-food products to the US reached \$9.4 billion, while imports from the US totaled \$7.4 billion. Canada's agri-food trade surplus with the US was up 16% to \$2 billion. Approximately 62% of total agri-food imports entering Canada were US products.

The merchandise trade data released by Statistics Canada on November 18, 1998, remain subject to revision, due to the timing of its reporting system. As such, the decline in exports may be overstated.

The consumer-oriented sector represented 63% of total two-way agri-food trade between Canada and the US. Exports of high-value consumer-oriented agri-food products from Canada to the US rose 21% to \$5.4 billion, while imports of similar products from the US were up 13% to \$5.3 billion.

Canada's agri-food trade with destinations other than the US during the first nine month period of 1998 was mixed. For example, exports to Rest-of-Asia (excluding Japan and China) declined 56% to \$648 million. Similarly, exports to Japan were down 39% to \$1.1 billion, while exports to China totaled \$395 million, down 11%. By contrast, Canada's exports to the EU-15 rose 3% to \$927 million and to Mexico were up 25% to \$324 million.

Imports from the EU-15 were up 10% to \$1.4 billion. Imports from Latin American countries continued to grow. Mexican agri-food products entering Canada (primarily vegetables, fruits and nuts) were up 13% to \$324 million, from Brazil were up 18% to \$286 million, and from Guatemala were up 28% to \$122 million. Canada's imports from Asia (including Japan and China) remained unchanged at \$704 million.

The Export Price Index (EPI) which measures the overall price conditions for Canada's agri-food exports was unchanged compared to the same period in 1997. However, the price situation varied significantly among export commodities. For example, export prices were down for grains, dried pulses, red meats, poultry and eggs, dairy and other animal products. Higher prices were registered for commodities such as oilseeds, oilseed products, animal feeds, fresh and processed vegetables, potatoes and alcoholic beverages.

Canada's total agri-food exports, as measured in volume terms, declined 8% during the first nine months of 1998. The drop in the total volume of exports was, in large part, a result of lower shipments of grains (especially wheat) but also from reduced volumes of animal feeds, dried pulses, oilseeds, seeds for sowing and fruits and nuts. By contrast, the Import Volume Index was up 10%, reflecting increased volumes of Canada's imports of grains, non-alcoholic beverages excluding juices, poultry and eggs, plantation crops and seed for sowing during the first nine month period of 1998.

PART I TRADE HIGHLIGHTS

Highlights for January-September 1998

Total Agri-Food Exports Down 8%

Total exports of Canadian agricultural and agri-food products were down 8% to approximately \$15 billion during the first nine month period of 1998. This represented a decline in exports of \$1.2 billion from the level registered during the same period in 1997. According to Statistics Canada, the trade performance of Canada's agri-food sector in the first three quarters of 1998 was significantly affected by lower sales in grains which fell by 42%.

Bulk Exports Down 31%

At \$4.2 billion, Canada's exports of bulk agricultural products were down 31%. Although the decline in grain exports was responsible for the weakened performance in bulk trade, other bulk exports were also down over the same period. For example, oilseed exports declined by 2% to \$1.2 billion. However, some bulk exports expanded during this period. For example, exports of soybeans were up 82% to \$174 million.

Intermediate Product Exports Down 1%

The trade data for the first three quarters of 1998 indicate a decline in exports of intermediate agri-food products, down 1% to \$4.1 billion. The lower exports recorded by oilseed products and animal feeds, down 5% and 16% respectively, were offset, in part, by increased exports in live animals (excluding poultry) and grain products, up 8% and 13% respectively.

Consumer-Oriented Exports Up 12%

Canada's exports of consumer-oriented agri-food products rose 12% to \$6.5 billion. Consumer-oriented products are now the main category of Canadian agri-food exports, representing 44% of the total value. However, the export situation varied among the components of this group. While exports of red meat products were down 4%, exports of potatoes and vegetables were both up 39%.




Figure 1: Canadian Trade of Agri-Food Products

Total Agri-Food Imports Up 10%

Total agri-food products entering Canada during the first nine months of 1998 reached \$12 billion, up 10%. The trade data indicate that most major agri-food categories rose significantly, compared to the same period in 1997. Consumer-oriented products were the largest group, representing 68% of total agri-food imports.

Bulk Commodity Imports Up 11%

Imports of bulk commodities rose 11% to \$1.9 billion. Canada's imports of grains (such as corn) rose 26%. Conversely, imports of oilseeds were down 21%.

Intermediate Product Imports Up 7%

At \$1.9 billion, imports of intermediate agri-food products were up 7%. The declines that were registered for intermediate imports, such as rapeseed oil (mainly canola oil), down 22%; and soybean oilcake and meal, down 10%, were offset by increased imports of products such as live animals excluding poultry, up 8%; and second transformation grain products, up 43%.

Consumer-Oriented Imports Up 11%

During the first nine months of 1998, consumer-oriented products continued to dominate agri-food imports entering Canada. At \$8.2 billion, consumer-oriented agri-food imports were up 11%. The most significant increases in consumer-oriented imports were recorded by poultry and eggs, up 22%; fresh and processed vegetables excluding potatoes, up 17%; and pasta products and alcoholic beverages, both up 16%.

Agri-Food Trade Surplus Down 45%

Canada's trade surplus in agri-food products was down 45% to \$2.9 billion compared to \$5.2 billion during the same period in 1997. The decline in the agri-food trade surplus was particularly significant for bulk commodities, down 48% to \$2.3 billion, as a result of the declines in shipments of barley, down 62%, wheat (other than durum), down 45%, oats, down 23%, and durum wheat, down 21%. The trade surplus in intermediate agri-food products was down 5% to \$2.3 billion.

In addition, Canada's agri-food trade deficit in consumer-oriented products reached \$1.7 billion, up 7%, in part as the result of the decline in the export value for fresh and frozen pork meats, down 26%, and increased imports of vegetables excluding potatoes, and alcoholic beverages, up 17% and 16%, respectively.

Export Price Index Unchanged

The Export Price Index (EPI), which measures the overall price conditions for Canada's agri-food exports, was unchanged compared to the same period in 1997. However, the situation varied significantly among the export commodities. Export prices were down in the case of grains, dried pulses, red meats, poultry and eggs, dairy and other animal products. Conversely, the trade data indicated higher prices for oilseeds, oilseed products, animal feeds, vegetables, potatoes and alcoholic beverages.




Figure 2: Export Price Index (EPI) for Selected Agri-Food Products

Total Export Volume Down 8%

Canada's total agri-food exports, measured in volume terms, declined 8% during the first nine months of 1998 compared to the same period in 1997. The drop in the total volume of exports resulted primarily from lower shipments of grains (especially wheat) but also from reduced volume of animal feeds, dried pulses, oilseeds, seed for sowing and fruits and nuts.

However, double-digit increases of volume were registered for products such as grain products (especially mixes and doughs and other bakery products), products made from plantation crops (coffee, cocoa and tea), fresh and processed vegetables, potato products, floriculture and nursery products and non-alcoholic beverages excluding juices.

Import Price Index Up 1%

The Import Price Index (IPI) for Canada's agri-food imports was up 1%. However, double-digit price increases were recorded for imports such as sugar products, up 74%; essential oils, up 44%; animal feeds, up 21%; and live animal (excluding poultry), up 15%. By contrast, import prices declined for seeds for sowing, down 17%; dried pulses, down 9%; grains (especially corn) and non-alcoholic beverages excluding juices, both down 6%.




Figure 3: Import Price Index (IPI) for Selected Agri-Food Products

Import Volume Index Up 10%

The volume of agri-food imports entering Canada was up 10% in the first nine months of 1998. Imports, as measured in volume, were up 67% for seeds for sowing, 41% for non-alcoholic beverages excluding juices, 34% for grains, 21% for poultry and eggs and 16% for plantation crops such as coffee beans. The trade data also indicated declines for some imports, especially sugar products, down 30%, and essential oils, down 22%. For the two major import categories, fruits & nuts and vegetables excluding potatoes, import volume rose 5% and 9% respectively.

Agri-Food Trade with the United States

Two-Way Agri-Food Trade Between Canada and the US Up 13%

Two-way agri-food trade between Canada and the US reached approximately \$17 billion, up 13%. Exports of Canadian agri-food products to the US totaled \$9.4 billion, up 13%, while imports rose 12% to \$7.4 billion. During the first nine month period of 1998, Canada's agri-food trade surplus with the US was up 16% to \$2 billion.

Consumer-Oriented Exports to the US Up 21%

Exports of high-value consumer-oriented products from Canada to the US rose 21% to \$5.4 billion. This category represented 57% of total exports to the US. Exports of intermediate products reached \$3 billion, up 8%. However, exports of bulk agri-food products to the US were down 6% to \$1 billion, which reflected lower volume of shipments especially for grain commodities, animal feeds and oilseed products.




Figure 4: Canada to United States: Trade of Agri-Food Products

Grain Exports
Down 23%, While
Exports of Grain
Products Rose 21%

At \$588 million, Canada's grain exports to the US, which mainly consisted of wheat, barley and oats, were down 23%. At \$244 million, exports of wheat other than durum were down 19%. Barley exports declined 23% to \$103 million while exports of oats were down 35% to \$126 million. The volume of exports for barley and oats were also down, 22% and 23% respectively. However, for grain products such as bakery products and pasta, exports to the US reached \$783 million, up 21%.

Oilseeds and Oilseed Product Exports Up 27% and 19% Respectively Canada's exports of oilseeds to the US totaled \$249 million, up 27%. Canola experienced a 20% increase in volume of shipments to the US which resulted in a 22% increase in value to \$105 million. Exports of oilseed products were up 19% to \$650 million, while products such as oil and oilcake & meal were up 52% and 19% to \$379 million and \$198 million respectively. However, exports of other oilseed products were down. For example, soybean oilcake and meal declined 70% to \$4 million.

Exports of Live Animals Up 9%, Exports of Red Meats Up 10% Live animals (excluding poultry) shipped to the US rose 9% to \$1.5 billion. Although the number of non-dairy cattle was down 5%, good price conditions in the US market resulted in a 4% increase in export value to \$1 billion. Exports of swine were up 13% to \$354 million. Increased hog shipments, up 38%, offset the decline in prices, down 18%. For red meats, exports were up 10% to \$1.3 billion. The decline by 11% in exports of pork meat to \$335 million was offset by an increase of 29% in beef, totaling \$765 million.

Exports of Dairy Products Up 57%, Poultry & Eggs Up 5% Canada's exports to the US market of cheese other than cheddar surged 75% to approximately \$20 million. As a result, total dairy exports rose 57% to \$77 million. Exports of poultry and egg products were up 5% to \$52 million. A decline in exports of live poultry, down 4% to \$23 million, was offset by an increase in exports of poultry meat both fresh and frozen, up 34% to \$13 million.

Vegetables Exports Up 43%, Potato Products Exports Up 54% At \$396 million, exports of fresh and processed vegetables from Canada to the US were up 43%. The most notable gain was registered by fresh tomatoes, up 69% to \$123 million. Exports of potato products increased 54% to \$395 million reflecting increases in shipments and favorable price conditions. At \$272 million, exports of frozen potatoes to the US were up 46%, mainly due to a volume increase of 29%.

Exports to the US of Other Canadian Products Were Mainly Up

Exports of Canadian-made products from plantation crops (i.e., coffee, cocoa and tea products) were up 46% to \$401 million. Cocoa products reached \$213 million, up 32%, while coffee products were up 85% to \$148 million. The floriculture sector performed well in the first nine months of 1998 with total exports up 32% to \$230 million. Exports of sugar and sugar products were up 12% to \$59 million. However, the trade data indicated a 10% decline to \$135 million for exports of Canadian fruits and nuts to the US.

Consumer-Oriented Products Accounted for 72% of Total Imports

At \$5.3 billion, consumer-oriented products represented 72% of total US agri-food products entering Canada. These imports were up 13% for the first nine period of 1998 compared to the same period in 1997. Imports of US poultry and eggs rose 23% to \$341 million, vegetables excluding potatoes were up 15% to \$980 million, while fruits and nuts reached \$1.1 billion, up 9%.

Double-Digit Increases for Most Import Groups from the US

With the exception of red meat imports which remained unchanged from the same period in 1997 at \$477 million and other animal products up 2% to \$255 million, most agri-food imports not previously mentioned were up in the double-digit range. Imports of sugar products from the US were up 62% to \$126 million. Non-alcoholic beverages (excluding juice) were up 40% to \$161 million. Products made from plantation crops (i.e., coffee, cocoa and tea) were up 35% to \$310 million. Seeds for sowing reached \$112 million, up 29%. Floriculture imports were up 16% to \$130 million while alcoholic beverages were up 13% to \$166 million.

Trade with Major Regions and Countries Other than the US

Exports to European Union Up 3%

At \$927 million, Canada's exports of agri-food products to the European Union (EU-15) were up 3%. However, the relative performances of various commodities varied significantly. For example, exports of grains and dried pulses declined 18% and 22% respectively, while oilseed exports rose 19% and animal products other than red meats were up 23%. Canada's oilseed products shipped to the EU-15 reached \$25 million, compared to \$8 million during the first nine months of 1997.

Exports to Japan Declined 39%

The trade data show a decline of 39% in Canadian agri-food exports to Japan during the first nine months of 1998, compared to the same period in 1997. All major exports to that destination declined markedly. Oilseeds were down 34% to \$443 million, red meats were down 33% to \$253 million, and grains (especially wheat) were down 66% \$127 million.

Exports to China Down 11%

The decline in grain exports to China, down 36% to \$215 million, weakened Canada's total agri-food exports to that country by 11% to \$395 million. However, some commodities did very well. Exports of oilseeds to China jumped to \$65 million from only \$2.4 million in the first nine months of 1997. Exports of oilseed products were up 77% to \$75 million.

Exports to Rest-of-Asia Down 56%

With some rare exceptions, such as alcoholic beverages (up 43% to \$23 million), agri-food commodities shipped to the Rest-of-Asia (excluding Japan and China) continued to fall through the first nine month period of 1998 as a result of the economic crisis affecting the Asian economies. Agri-food exports were down 56% to \$648 million to the region. For example exports to South Korea declined 78% to \$76 million compared to \$340 million in the first nine months of 1997.

Exports to Latin America Remained Mixed

Canada's exports of agri-food products to Mexico reached \$324 million a gain of 25% over the same period in 1997. These mainly consisted of grains and oilseeds which totaled \$124 million (up 18%) and \$123 million (up 11%), respectively. Exports to Brazil were down 42% to \$132 million. The value of grain exports for Brazil were down 61% to \$62 million while grain product exports were unchanged at \$32 million.

Exports to several Latin American countries declined markedly during the first nine months of 1998. Exports to Venezuela declined 15% to \$133 million, to Colombia declined 23% to \$92 million, to Peru declined 45% to \$56 million and to Chile declined 51% to \$37 million. However, the smaller markets in the region continued to provide growing opportunities for Canadian products. For example, exports to Cuba rose 8% to \$79 million.

North African Markets Remained Strong, **Exports to Other Markets Varied**

At \$430 million, the Algerian market continued to represent a major destination for Canadian agri-food exports. Exports to Morocco were up 29% to \$92 million. However, exports to Libya were down 48% to \$79 million. The trade data indicate a 52% increase to \$61 million of exports to South Africa, while exports to Russia were down 9% to \$84 million and to Saudi Arabia down 82% to \$25 million compared to \$137 million in the first nine months of 1997.




Figure 5: Canadian Agri-Food Exports to Destinations Other than the U.S.

EU-15 Agri-Food Products Entering Canada Up 10%


Canada's imports of agri-food products from the EU-15 reached \$1.4 billion, up 10%. Alcoholic beverages (mainly grape wine) represented 37% of these imports, or \$506 million up 18%. Products from plantation crops (i.e., cocoa, coffee and tea) reached \$119 million, up 7%. Other major agri-food imports from the EU-15 included vegetable products (excluding potatoes), up 45% to \$84 million, and dairy products (mainly cheese), up 6% to \$83 million.

Imports from Asia Were Unchanged

At \$704 million, Canada's imports from Asia remained unchanged compared to the same period in 1997. While plantation crops represented 37% of imports from Asia, they were down 10% compared to last year. Imports of other Asian agri-food products were mostly up. Imports of fruits and nuts were up 5% to \$97 million and grains, such as rice, rose 12% to \$51 million.

Imports from Latin America Continued to Grow

Imports from Mexico reached \$324 million, up 13%. They were comprised primarily of fruits and nuts, up 20% to \$103 million, and vegetables (excluding potatoes), up 12% to \$102 million. Although imports of Brazilian plantation crops, especially coffee beans, were down 3% to \$119 million, total imports from Brazil rose 18% to \$286 million. Imports from Colombia rose 3% to \$192 million and imports from Guatemala increased by 28% to \$122 million. While overall imports from Latin American countries continue to expand, imports from Chile declined 1% to \$161 million.



Export Highlights for Selected Commodity Groups

The Value of Grain Exports Was Down 42%

According to Statistics Canada's trade data, Canada's total exports of grains (i.e., wheat, barley, oats, corn and others) were down 42% compared to the same period in 1998, primarily because of significant declines in the volume of shipments of major grain commodities. Exports as measured by volume were down 45% for wheat (other than durum) while durum declined 21%. The volume of exports for barley was down 62%, and for oats was down 23%. In value terms, exports of wheat (other than durum) fell to \$1.6 billion, down 47%. Exports of durum wheat were down 10% to \$751 million, barley down 63% to \$166 million, and oats down 34% to \$131 million.

Exports of Grain Products Up 14%

Exports of grain products (such as pasta and bakery products) rose 14% to \$971 million. This was the result of gains made by "mixes and doughs", up 53% to \$120 million; other bakery products, up 15% to \$395 million; wheat flour (other than from hard spring wheat), up 35% to \$32 million; pasta products, up 94% to \$76 million and second transformation grain products, up 2% to \$95 million.

Exports of Oilseeds Down 2%

Although exports of soybeans rose 82% to \$174 million, the overall performance of the oilseed commodities was marked by a decline in exports of 2% to approximately \$1.2 billion. Exports of canola were down 12% to \$739 million, flaxseed down 3% to \$175 million and mustard seed down 4% to \$56 million.

Exports of Oilseed Products Were Unchanged

Exports of oilseed products totaled \$812 million for the first nine months of 1998, a value similar to the corresponding period in 1997. Declines in some oils and fats were offset by export increases registered by rapeseed oil, up 7% to \$487 million; rapeseed oilcake and meal, up 14% to \$228 million; and soybean oilcake and meal, up 13% to \$22 million.

Dried Pulses and Animal Feeds Exports Declined 15% and 10% Respectively

At \$296 million, Canada's exports of dried pulses were down 15% resulting from a decline in the volume of these exports. Prices remained unchanged. For animal feeds, exports were down 10% to \$591 million. With the exception of dog and cat food, up 8% to \$155 million and complete feeds, which have remained unchanged at \$188 million, exports of animal feed products, such as hay, crop by-products and dehydrated alfalfa, were down markedly during the first nine months of 1998.

Exports of Red Meat Down 4%

Exports of red meat totaled \$1.8 billion, a drop of 4% from the same period in 1997. However, good price conditions and increased shipments have resulted in higher exports of beef meat (i.e., fresh and frozen meat and edible offal), up 24% to \$818 million. By contrast, the value of Canadian pork meat exports declined 26% as a result of low world prices for fresh and frozen pork. Exports of pork products, such as sausages and similar products, were down 14% to \$80 million.




Figure 7: Canadian Exports of Selected Agri-Food Commodity Groups

Exports of Live Animals Up 8%

Strong prices helped to increase the value of exports of live non-dairy cattle to \$1 billion, up 4%. In addition, an increase of 38% in the number of swine shipped from Canada resulted in a 13% increase in exports to \$354 million. The trade data also show exports of dairy cattle totaling \$52 million compared to \$39 million for the same nine month period of 1997. Overall, total exports of live animals rose 8% to \$1.5 billion.

Dairy Exports Up 6%

Canada's exports of dairy products were up 6% to \$279 million. Increased shipments and good prices for cheeses (other than cheddar) resulted in a 30% increase in the value of exports to \$51 million. Significant gains were also recorded for unsweetened condensed milk, up 14% to \$53 million, and cheddar cheese, up 9% to \$44 million. At \$45 million, exports of skim-milk powder were up 30%.

Exports of Poultry and Eggs Up 2%

At \$137 million, exports of poultry and egg products were up 2%. Declines in exports of hatching eggs, down 16% to \$22 million; prepared eggs, down 12% to \$14 million, and live poultry, down 2% to \$29 million, were offset by increases in exports of poultry meat, such as fresh and frozen poultry meat, up 10% to \$62 million, and prepared poultry meat, up 58% to \$9 million.

Vegetables and Potato Exports Both Up 39%

Exports of fresh and frozen vegetables totaled \$432 million, up 39% compared to the first nine months of 1997. Strong prices in the US combined with increased shipments resulted in a 69% increase in exports of fresh tomatoes which totaled \$123 million. Fresh tomatoes represent 28% of total exports of fresh and processed vegetables excluding potato products. Processed vegetable exports were up 37% to \$90 million.

At \$474 million, exports of potato products were up 39%. Canada's exports of frozen potatoes reached \$327 million, up 32%. Frozen potatoes represent 69% of total exports of potato products. The fresh sector also expanded rapidly. Exports of fresh table potatoes were up 88% to \$89 million and seed potatoes rose 56% to \$44 million.

Import Highlights for Selected Commodity Groups

Imports of Grains Up 26%, Grain Products Up 9%

Total value of grain imports to Canada reached \$308 million, up 26%. This increase was primarily the result of a surge in corn imports which totaled \$155 million, up 56%. The value of rice imports was up 7% to \$133 million. This was due to higher prices. Import volume of rice declined 2% in the first nine months of 1998. The value of wheat imports, other than durum, was down 20% to \$13 million.

At \$690 million, imports of grain products rose 9% over the same period in 1997. Declines in imports of mixes and doughs, down 2% to \$55 million, and first transformation grain products, down 4% to \$40 million, were offset by increased imports of pasta products, up 16% to \$155 million. Imports of bakery products other than "mixes and doughs" were unchanged at \$277 million.

Imports of Oilseeds Down 21%, Oilseed Products Down 6% Canada's imports of oilseeds totaled \$180 million, down 21%. Although imports of canola rose 34% to \$40 million, imports of the major oilseed commodities declined in the first nine months of 1998. Imports of ground-nuts were down 3% to \$86 million, while soybeans were down 72% to \$24 million.

At \$427 million, imports of oilseed products, such as oils and meals, were down 6% as a result of a decline in volume of some commodities included in the product group. The volume of rapeseed oil was down 33% while import volumes of oils and fats NES were down 6%. Although the volume of soybean oilcake and meal rose 10%, relatively low prices resulted in a decline in the value of imports to \$187 million, down 10%.

Red Meat Imports Up 1%, Live Animal Imports Up 8%

Total imports of red meats (i.e., mainly beef and pork) reached \$749 million, up 1%. A decline in beef imports was offset, in part, by increases in imports of pork, processed beef and pork products. Fresh and frozen beef were down 5% to \$447 million due to lower volumes of imports. By contrast, a 17% increase in volume of fresh and frozen pork meat resulted in an increase of 8% to \$101 million compared with the same period in 1997. Imports of processed beef reached \$54 million, up 26%, sausages were up 14% to \$47 million and prepared pork products were up 9% to \$24 million.

Imports of live animals were up 8% to \$87 million mainly as a result of increased imports of dairy cattle other than purebred which reached \$43 million, up 29%. Imports of other animals (excluding cattle) were down 16% to \$40 million.

Imports of Dairy Products Up 1%, Poultry & Eggs Up 22%

At \$198 million, dairy imports were up 1%. Cheeses other than cheddar represented 60% of Canada's total dairy imports during the first nine months of 1998 reaching \$119 million, up 14%. Imports of powdered milk (excluding skim-milk powder) rose 48% to \$13 million. However, other dairy products NES were down 23% to \$56 million.

Canada's imports of poultry and egg products totaled approximately \$344 million, up 22%. The volume of fresh and frozen poultry meat entering Canada was up 32%. As a result, poultry imports were up 21% to \$148 million or 43% of total imports of this category of items. Processed poultry meat imports reached \$90 million, up 17%. Live poultry imports were also up, registering an increase of 31% to \$38 million. Imports of fresh and processed eggs (excluding hatching eggs) were up 42% to \$56 million.




Figure 8: Canadian Imports of Selected Agri-Food Commodity Groups

Imports of Fruits And Nuts, Our Largest Import Category, Up 4% Fruit and nut products remained the largest group of imports in the first nine months of 1998. At \$2 billion (up 4%), fruits and nuts represented 17% of total agri-food imports. While imports of fresh grapes were down 2% to \$192 million and fresh bananas and plantains remained unchanged at \$182 million, the value of other major imports in the fruit and nut category increased. For example, fresh apples were up 17% to \$105 million, oranges and other fresh citrus commodities were up 4% to \$177 million, and fresh and dried nuts were up 13% to \$129 million.

Vegetable Imports Up 17%, Potatoes & Products Up 4%

At \$1.2 billion, imports of fresh and processed vegetables were up 17%. Fresh tomatoes and fresh lettuce reached \$141 million (up 7%) and \$137 million (up 26%), respectively. Fresh vegetables NES rose 11% to \$169 million. Increases were also registered by processed vegetable products. Canned vegetables were up 45% to \$94 million, frozen vegetables were up 12% to \$49 million, while "prepared" vegetables reached \$193 million, up 3%. Canada's imports of potato products, especially fresh and frozen potatoes increased by 4% to \$187 million.

Plantation Crop Imports Up 15%, Sugar & Products Up 21%

Increased imports of coffee, cocoa and tea products resulted in total imports of plantation crops increasing 15% to \$1.3 billion. Strong prices combined with greater domestic demand resulted in a 35% increase of Canada's imports of cocoa beans and products to \$334 million. Imports of coffee beans and products reached \$695 million, up 19%. Imports of sugar and sugar products totaled \$385 million, up 21%. While raw sugar remained the major component of total imports of sugar products at \$231 million, up 5%, molasses and syrups imports increased by 53% to \$141 million.

Imports of Alcoholic Beverages Up 16%; Other Agri-Food Products Up 13% Although imports of distilled beverages declined 1% to \$202 million, increased imports of grape wine (up 24% to \$488 million) and beer and stout (up 20% to \$110 million) resulted in a 16% increase of total imported alcoholic beverages in the first nine months of 1998. Imports of non-alcoholic beverages excluding juices were up 33% to \$198 million. Other agri-food products, such as, material for food preparation rose 13% to \$1.4 billion.
