Preface

This report provides highlights of Canadian agri-food trade in the first six months of 1999. Emphasis is placed on changes in major trade flows compared to the same period in 1998. These changes include four areas: exports and imports; trade balance; the performance of bulk, intermediate and consumer-oriented products; as well as major destinations of Canadian products and sources of foreign supply.

In addition to a description of Canada's agri-food trade, this report also contains a feature article analysing the linkage between agri-food exports and farm income.

We have not included information concerning changes in price and volume indices in this report. We are developing a new methodology for the calculation of these indices and we will then provide the data.

Please note that the data in this report may be subject to revision, and therefore the interpretation of the data should be treated with caution. Statistics Canada is in the process of revising its data collection procedures. Executive Summary

At \$9.9 billion, the total value of Canada's agri-food exports during the first six months of 1999 was down 13%, compared to the same period in 1998. Total agri-food exports fell as sales of grains, oilseeds and oilseed products, and live animals (excluding poultry) declined more than 20%. However, exports of grain products such as wheat flour and pasta products increased 15%, red meats increased 19%, and dried pulses increased 27%.

Exports of grain commodities were down 46% to \$1.4 billion for the January to June period as a result of decreases in the value of wheat exports as well as declines in barley, oat, and rye exports. The drop in the value of Canadian wheat exports, the major grain export, accounted for the largest portion of the decline in Canadian grain exports. Lower world prices for wheat were a major contributor to the decline in the value of wheat exports, as well as a limited domestic supply availability. The key factors contributing to lower world wheat prices have been excess wheat supplies in major exporting countries, caused largely by a strong cyclical response to high prices in the mid-1990s, combined with reduced world demand due to limited or negative economic growth in a number of regions. The declines in Canada's exports of oilseeds (down 26% to \$812 million) and oilseed products (down 35% to \$469 million) reflect the relatively lower world oilseed prices, which are associated with a strong supply response to higher prices in previous years combined with weak international demand.

Exports of live animals (excluding poultry) totalled \$781 million, down 21%, reflecting a decline in exports of non-dairy cattle and swine. With increases in domestic slaughtering and processing capacity, exports of live non-dairy cattle were down 22% to \$519 million, and exports of live swine were down 36% to \$157 million. By contrast, total exports of red meats (i.e. beef and pork products) were up 19% to \$1.4 billion as more meat was processed in Canada.

Total imports of agri-food products to Canada reached \$8.1 billion, up 2% compared to the January to June period in 1998. With few exceptions, imports of most major agri-food categories increased. Imports of fruit and nuts, which represented 18% of total agri-food imports, increased 10% to \$1.4 billion. Imports of alcoholic beverages were up 19% to

\$607 million and grain products (such as pasta products and bakery products) reached \$467 million, up 7%. Imports of red meats were down 1% to \$506 million, while imports of plantation crop products such as coffee, tea and cocoa products, declined by 11% to \$749 million.


Canada's agri-food trade surplus totalled \$1.8 billion, a decline of 48% compared to the January to June period in 1998. Trade surpluses for bulk and intermediate commodities were down 48% to \$1.4 billion and 25% to \$1.3 billion, respectively, reflecting declines in exports of grains, oilseeds and live animals. However the trade deficit for consumer-oriented products, \$965 million, was less than the \$1.1 billion deficit reported in the same period in 1998. Overall, the two-way trade in agri-food products totalled \$18 billion, down 7%.

At \$6.4 billion, exports to the U.S. represented 66% of the total value of Canada's agri-food products shipped in the first six months of 1999. Exports to the U.S. were up for red meats (24% to \$1.1 billion), grain products (24% to \$614 million), alcoholic beverages (5% to \$388 million) and potato products (4% to \$306 million). By contrast, the value of grain shipments to the U.S. were unchanged at \$387 million, while the value of oilseed products and live animals (excluding poultry) shipments were down (11% and 22% to \$392 million and \$774 million, respectively). The total value of two-way agri-food trade between Canada and the U.S. was up 1.8% to \$11 billion. Canada's agri-food trade surplus with the U.S. reached \$1.4 billion, up 17%.

Exports to the European Union (EU-15) were down 23% to \$533 million reflecting declines in exports of grains (43% to \$94 million), oilseeds (23% to \$73 million), animal products other than red meats (44% to \$53 million), and raw tobacco (27% to \$28 million). Exports to Japan were down 11% to \$888 million, as exports of grains fell (42% to \$108 million), as did exports of grain products (22% to \$44 million) and exports of oilseeds (10% to \$356 million). Despite economic difficulties in Japan, exports of red meats to the Japanese market increased 12% to \$206 million. Exports to the rest-of-Asia (excluding Japan) were down 39% to \$732 million, reflecting the economic slowdown which has prevailed in this region. Total exports to Mexico were down 34% to \$197 million, reflecting a decline in grain (47%) and oilseed (49%) exports.


Canada's agri-food imports from sources other than the U.S. increased 4% to \$3.2 billion. Imports from the EU-15, which represented 12% of the total imports, experienced a 14% increase to \$955 million. This increase was primarily the result of a rise in the value of alcoholic beverages. Canada's agri-food

imports from South America were up 11% to \$635 million. A 13% decline in imports from Colombia to \$115 million offset increases in imports from Brazil (26% to \$203 million) and Chile (11% to \$149 million). Imports from the Caribbean and Central America (including Mexico) were down 11% to \$489 million.



Highlights for January to June 1999



Total agri-food exports down 13%

Canada's total exports of agri-food products declined 13% to \$9.9 billion during the January to June 1999 period, compared to the same period in 1998. This decline resulted primarily from the reduced value of shipments to the EU-15, Japan and the rest-of-Asia. The U.S. was the primary export destination, accounting for 66% of Canada's total value of agri-food exports. Other major destinations were Japan (9%), the rest-of-Asia (7%) and EU-15 (5%) (Figure 1).



Total agri-food imports up 2%

Canada's imports of agri-food products totalled \$8.1 billion during the period of January to June 1999, up 2% over the same period in 1998. Most of these imports originated from the U.S., which accounted for 60% of the total agri-food products entering Canada. Other major sources of agri-food imports to Canada were the EU-15 representing 12%, South America representing 8%, Asia representing 6%, and the Caribbean and Central America also representing 6% (Figure 2).



Bulk exports down 38%, intermediate product exports down 14% but consumer-oriented exports up 12%

At \$2.5 billion, Canada's exports of bulk agri-food commodities were down 38% mainly resulting from lower grain and oilseed prices as well as lower volumes of wheat exports. Exports of intermediate products were down 14% to \$2.6 billion, reflecting a decline of 35% in the value of oilseed product exports and 21% in live animals (excluding poultry). By contrast, exports of consumer-oriented agri-food products were up 12% to \$4.8 billion (Figure 3).

Bulk imports down 17%, intermediate products imports up 1% and consumer-oriented imports up 6%

Total imports of bulk agri-food commodities reached \$1.1 billion, down 17% compared to the same period in 1998. The decline in the value of bulk imports reflects a 61% fall in the value of corn imports. Imports of intermediate products were up 1% to \$1.3 billion. While imports of oilseed products were down 12% to \$251 million, grain product imports were up 7% to \$467 million. Canada's imports of consumer-oriented agri-food products were up 6% to \$5.7 billion (Figure 4).

Agri-food trade surplus down 48%

Canada's agri-food trade balance registered a surplus of \$1.8 billion during the first six months in 1999. This surplus declined 48% compared to the same period in 1998 when Canada's agri-food trade surplus reached \$3.4 billion. The trade surplus was down for bulk commodities, 48% to \$1.4 billion, and down for intermediate commodities, 25% to \$1.3 billion. By contrast, the trade deficit for consumer-oriented agri-food products decreased from \$1.1 billion in the first six months of 1998 to \$965 million during the same period in 1999.

Exports of Selected Commodity Groups

Exports of grains down 46% and oilseeds down 26%

Based on data provided by Statistics Canada, the value of Canadian grain exports declined 46% to \$1.4 billion during the first half of 1999 compared to the same period in 1998 (Figure 5). Grain exports accounted for an important portion (15%) of total Canadian agri-food exports (Figure 6). The decline in the value of grain exports reflects decreases in the value of wheat exports as well as declines in barley, oat, and rye exports. The drop in the value of Canadian wheat exports, the major grain export, accounted for the largest portion of the decline in Canadian grain exports.




Lower world prices for wheat was a major contributor to the decline in the value of wheat exports, as well as a limited domestic supply availability. The key factors contributing to lower world wheat prices have been excess wheat supplies in major exporting countries, caused largely by a strong cyclical response to high prices in the mid-1990s, combined with reduced world demand due to limited or negative economic growth in a number of regions.

Lower world prices for oilseeds contributed to a 26% decline, to \$812 million, in the export value of oilseeds. Canola, which represented 75% of the total value of oilseed exports, was down 26% to \$580 million. The value of other oilseed exports also declined, such as flaxseed (down 30%) and soybeans (down 24%). Lower oilseed prices are associated with a strong supply response to higher prices in previous years combined with weak international demand.

Exports of grain products up 15%, oilseed products down 35%

Exports of grain products were up 15% to \$733 million, reflecting increases in the value of exports such as bakery products, flour, and pasta products. The total export value of oilseed products, such as rapeseed and soybean oils, oilcakes and meals, declined 35% to \$469 million reflecting declines in world prices for oilseed products.

Exports of dried pulses up 27%, animal feeds down 6%

In the January to June period in 1999, exports of dried pulses reached \$311 million, up 27% compared to the same period in 1998 as a result of increased world demand. The value of animal feeds exports fell by 6% to \$374 million.

Exports of red meats up 19%, live animals down 21%

Total exports of red meats (i.e. beef and pork products) increased 19% to \$1.4 billion as more meat was processed in Canada. By contrast, total exports of live animals (excluding poultry) were down 21% to \$781 million, reflecting declines in exports of non-dairy cattle and swine. With increases in domestic slaughtering and processing capacity, exports of live non-dairy cattle were down 22% to \$519 million, and exports of live swine were down 36% to \$157 million.

Exports of dairy products down 4%, poultry and eggs down 9%

Canada's exports of dairy products declined 4% to \$182 million. This decline reflects depressed world prices and the fact that the recent export contracts with Algeria and Libya have not been signed to date. Exports of poultry and eggs were

down 9% to \$85 million as a result of reduced exports of live poultry and poultry meat, since exports of hatching eggs and processed egg products were up 12% and 15%, respectively.

Exports of potatoes and potato products up 8%, other vegetables up 16%

The total export value of fresh potatoes and potato products reached \$386 million, up 8%. While the value of table potato exports declined 15% to \$65 million, frozen potato product exports increased 17% to \$263 million. The total value of exports of other fresh and processed vegetables totalled \$284 million, up 16%.

Exports of alcoholic beverages up 5%, processed plantation crops down 4%

At \$429 million, exports of alcoholic beverages were up 5%. Exports of plantation crops, such as coffee, cocoa and tea products, that were processed in Canada, declined 4% to \$267 million. Floriculture and nursery product exports were up 13% to \$213 million. The value of exports of other agri-food products, such as confectionery products, condiments, and inputs into other manufacturing, increased 20% to \$672 million.

Imports of Selected Commodity Groups

Imports of grains down 35%, grain products up 7%

During the first six months of 1999, imports of grains totalled \$136 million, down 35%, while imports of grain products increased 7% to \$467 million (Figure 7). Among the processed grain products, imports of mixes and dough increased 18% to \$40 million, and other bakery products reached \$176 million, up 3%. Pasta product imports increased 9% to \$111 million.

Imports of fruit and nuts up 10% and fresh and processed vegetables unchanged

Imports of fruit and nuts, which represented 18% of Canada's total imports of agri-food products in the January to June period in 1999 (Figure 8), were up 10% to \$1.4 billion as

declines in imports of oranges and other fresh citrus fruit (17% to \$108 million) offset increases in imports of fresh grapes (10% to \$127 million). By contrast, imports of fresh and processed vegetables (excluding potatoes), which accounted for 12% of total agri-food imports, were unchanged at \$953 million. Imports of fresh and processed potatoes were down 13% to \$111 million mainly reflecting declines in imports of table potatoes and seed potatoes.

Imports of plantation crops down 11%, alcoholic beverages up 19%

During the January to June period in 1999, Canada's imports of plantation crops and products made from these commodities such as coffee, tea, cocoa and rubber totalled \$749 million, down 11%. Imports of coffee and products declined 13% to \$401 million, and imports of cocoa and products were down 5% to \$205 million. Imports of alcoholic beverages were up 19% to \$607 million, as imports of grape wine totalled \$357 million, up 18% compared to the same period in 1998.

Imports of pork down 18% and beef unchanged

Total imports of fresh and frozen red meats were down 1% to \$506 million (Figure 7), primarily as a result of an 18% decline in imports of fresh and frozen pork meat to \$58 million. Imports of fresh and frozen beef were unchanged at \$308 million. Imports of some processed meats were up, as imports of prepared beef imports including meals were up 21% to \$40 million and sausages and similar products were up 2% to \$31 million. Imports of other animal products, such as hides, furs and wool, declined 4% to \$238 million.

Imports of cheese (other than cheddar) up 27%, poultry meat (fresh and frozen) down 6%

The 20% increase in the total value of dairy product imports to \$147 million (Figure 7) reflects a 27% rise in imports of cheese other than cheddar to \$91 million. Imports of total poultry products and egg products were down 9% to \$205 million as a result of declines in imports of all products in that group. Imports of poultry meat (fresh and frozen) were down 6% to \$87 million, and prepared poultry products declined 12% to \$55 million.







Agri-Food Trade with the United States

Two-way agri-food trade between Canada and the U.S. up 2%

The value of total agri-food trade between Canada and the U.S. reached \$11.3 billion, up 1.8% compared to the January to June period in 1998. Exports of Canadian agri-food products to the U.S. were up 3% to \$6.4 billion, or 66% of the value of Canada's agri-food exports to all destinations. Canadian imports from the U.S. were unchanged at \$5 billion and constituted 60% of Canada's total agri-food imports. The agri-food trade surplus with the U.S. increased 17% to \$1.4 billion.



Bulk and intermediate exports to the U.S. down 8% and 13% respectively, and consumer-oriented exports up 15%

Compared to the first half of 1998, exports of bulk agri-food products declined 8% to \$662 million, while exports of intermediate products were down 13% to \$1.7 billion (Figure 9). Exports of consumer-oriented products increased 15% to \$4 billion, and represented 62% of the total Canadian agri-food exports to the U.S. This rise in consumer-oriented agri-food exports reflects a long term trend in the agri-food trade between Canada and the U.S.

Bulk and intermediate imports from the U.S. down 14% and 1% respectively, and consumer-oriented imports up 2%

Canada's imports of U.S. bulk products were down 14% to \$409 million, while imports of intermediate products declined 1% to \$948 million (Figure 10). Imports of U.S. consumeroriented agri-food products were up 2% to \$3.6 billion; this group of products represented 72% of the total value of U.S. agri-food goods entering Canada during the period.

Exports of Selected Commodities to the U.S.

Exports of live animals to U.S. down 22%, red meats to U.S. up 24%

Exports from Canada to the U.S. of live animals (excluding poultry) declined 22% to \$774 million as more animals were processed domestically. This reflects a decline in exports of non-dairy cattle (22% to \$519 million) and swine (36% to \$156 million). At the same time, Canada's exports to the U.S. of red meats, mainly beef and pork, were up 24% to \$1 billion. Red meats accounted for a major portion (16%) of total agrifood exports to the U.S. (Figure 11). With increased slaughtering capacity in Canada, exports to the U.S. of fresh and frozen beef reached \$631 million, up 26%. Exports of fresh and frozen pork increased 23% to \$260 million, and exports of prepared pork products including meals were up 10% to \$49 million.

Exports of grains to the U.S. unchanged, grain products up 24%

At \$387 million, total grain exports to the U.S. were unchanged compared to the same six month period in 1998. Exports of wheat (other than durum wheat) declined 5% and exports of durum wheat increased 24%. Bakery products other than mixes and dough, which represent a large share of total grain product exports, were up 19% to \$280 million.

Exports of oilseed products to U.S. down 11%

Exports of Canadian oilseed products to the U.S. were down 11% to \$392 million. This decrease mainly reflects a decline in the export value of canola oil and other canola products (i.e. oilcake and meal) which represented 58% and 27%, respectively, of the total value of oilseed products shipped to the U.S. Exports of canola oil were down 11% to \$227 million, while exports of canola oilcake and meal were down 22% to \$105 million.


Exports of alcoholic beverages to U.S. up 5%

Exports of alcoholic beverages to the U.S., including distilled beverages and beer and stout, were up 5% to \$388 million. While exports of distilled beverages increased 10% to \$250 million, exports of beer and stout were down 6% to \$131 million.

Exports of potatoes and potato products to U.S. up 4%

The 21% decline in exports of table potatoes to \$49 million offset an 11% increase in exports of frozen potatoes to \$207 million. Exports of seed potatoes were up 2% to \$41 million. Overall, Canadian exports to the U.S. of potatoes and potato products were up 4% to \$306 million.

Imports of Selected Commodities from the U.S.

Imports of vegetables from the U.S. down 1%, potatoes and potato products down 11%

Fresh and processed vegetables is the largest category of imports from the U.S., accounting for 15% of the value of all agri-food imports (Figure 12). Overall, Canada's imports of fresh and processed vegetables from the U.S. declined 1% to \$737 million. While the value of certain vegetable imports was

up, such as fresh tomatoes (12%) and vegetable juices (13%), the value of other vegetable imports fell, such as canned vegetables (3%) and preserved vegetables (3%). Total potato and potato product imports declined 11% to \$109 million, mainly as a result of lower table and seed potatoes import values.

Imports of fruit and nuts from U.S. up 3%

At \$699 million, fruit and nuts represented 14% of total agrifood imports from the U.S. in the January to June period in 1999 (Figure 12). Imports of fresh berries were up 24%, totalling \$76 million, while imports of fresh oranges and other citrus fruit were down 47% to \$57 million. Imports of fruit juices from the U.S. were up 14% to \$179 million.

Imports of grain products from U.S. up 7%

The total value of grain product imports, such as bakery and pasta products, reached \$386 million, up 7%. Imports of bakery products other than mixes and dough totalled \$144 million, up 1%. Pasta product imports increased 12% to \$74 million, and imports of mixes and dough for the preparation of bakery products were up 18% to \$37 million.

Imports of red meats from the U.S. down 8%, other animal products also down 8%


Canada imported \$297 million worth of red meats from the U.S. in the first six month of 1999, down 8%. This decline was due in part to a drop in imports of fresh and frozen beef and pork as Canada's domestic slaughtering capacity recently increased. Imports of other animal products from the U.S. were also down 8%, to \$178 million.

Imports of animal feeds from the U.S. up 4%, plantation crops up 14%, and poultry and eggs down 9%

Imports of animal feeds from the U.S. totalled \$267 million, up 4%, during the January to June period in 1999. These imports represented 5% of total agri-food imports from the U.S. during this period (Figure 12). Imports of products made from

plantation crops, such as coffee, tea and cocoa, increased 14% to \$ 215 million. Imports of poultry products and egg products declined by 9% to \$203 million.

Trade with Major Regions and Countries Other than the United States

Exports to Destinations Other than the U.S.

Exports to the European Union down 23%

At \$533 million, Canada's agri-food exports to the European Union (EU-15) declined 23% (Figure 13), as values of shipments of grains, oilseeds, certain animal products, and raw tobacco were down resulting in part from low commodity prices. Exports of grains were down 43% to \$94 million reflecting a decline in wheat exports. Exports of oilseeds totalled \$73 million, down 23%, and exports of raw tobacco declined 27% to \$28 million. However, exports of Canadian dairy products increased 24% to \$29 million.

Exports to Japan down 11%

Canada's total agri-food exports to Japan were down 11% to \$888 million in the January to June period in 1999 (Figure 13), even though there was a 12% increase to \$206 million in the exports of red meats during this period. Exports of grains were down 42% to \$108 million, grain product exports were down 22% to \$44 million, and oilseed exports were down 10% to \$356 million.

Exports to the rest-of-Asia down 39%

Canada's exports to the rest-of-Asia (Asia excluding Japan), which totalled \$731 million, were down 39% (Figure 13). Exports to China were down 47% to \$218 million, reflecting a 77% decline in grain exports to \$48 million and 18% decline in oilseeds exports to \$127 million. While exports to South Korea dropped 21% to \$89 million, exports of red meat to this destination increased from \$10 million to \$32 million. Exports to Indonesia were down 69% to \$46 million.

Exports to Mexico down 34%, Algeria down 31%, Iran down 21%

The value of Canada's agri-food exports to Mexico declined 34% to \$197 million during the January to June 1999 period, with grains down 47% to \$49 million and oilseeds down 49% to \$80 million. However, Canada's exports of red meats to Mexico increased from \$4 million to \$22 million. Exports to Algeria were down 31% to \$234 million and exports to Iran were down 21% to \$125 million. Canada's total agri-food exports to South America were \$289 million, up 40% compared to the same period in 1998.

Imports from EU-15 up 12%

Canada's imports of agri-food imports from the EU-15 increased 14% to \$955 million (Figure 14). Imports of alcoholic beverages such as grape wine and distilled beverages, which represented 40% of total agri-food imports from the EU-15, totalled \$382 million, up 22%. Imports of dairy products (represented primarily by cheeses other than cheddar cheese) were up 32% to \$66 million. Imports of fruit and nuts increased 34% to \$46 million.


Imports from Asia up 1%

At \$472 million, imports from Asia increased 1% compared to the January to June 1998 period. Declines in imports of plantation crops and grains (such as rice) of 18% to \$143 million and 7% to \$32 million, respectively, offset increases in imports of fruit and nuts of 28% to \$76 million, of grain products of 17% to \$35 million, and of vegetables (excluding potatoes) of 33% to \$41 million.

Imports from Mexico down 9%

Canada's agri-food imports from Mexico declined 9% to \$240 million (Figure 14), reflecting a decline in imports of vegetables (excluding potatoes) of 14% to \$83 million and of plantation crops of 46% to \$20 million. Imports from Guatemala were down 16% to \$71 million. By contrast, imports from Chile totalled \$149 million, up 11%, in part due to increased imports of fruit and nuts, up 12% to \$112 million. Imports from Brazil were up 26% to \$203 million, as imports of plantation crops increased 37% to \$96 million, and imports of fruit and nuts increased 18% to \$68 million. Imports from Australia reached \$190 million, up 9%.

Effects of Agri-Food Exports on Farm Income

Introduction

This article considers the impact of two hypothetical 'events' in world markets on the value of Canada's agri-food exports³ and Canadian net cash farm income.⁴ We use two scenarios to illustrate these effects; the first scenario involves a decrease in tariffs by Canada's trading partners, while the second looks at the effects of a depreciation of the Canadian dollar (approximated by a lower real exchange rate). For each scenario, these changes are designed to generate a \$1 billion increase in agri-food export value. We estimate that the increase in net cash farm income arising from the \$1 billion increase in agri-food export value is \$250 million for the first scenario and \$310 million for the second. Through indirect and induced effects, the remainder of the \$1 billion increase (\$750 million and \$690 million respectively) is passed on to other segments of the agri-food sector, such as to the input, processing and manufacturing sectors, as well as to other sectors in the Canadian economy.

The Importance of Exports


Between 1993 and 1998, the value of Canadian agri-food exports increased 50%. This change can be attributed to increases in the physical volume traded (18%), increases in world market prices (27%) and the depreciation of the Canadian dollar against most currencies. The composition of these agri-food exports, including both raw and processed products, also changed. After the period of rationalization and restructuring that occurred around the time of the implementation of the Canada-U.S. Free Trade Agreement, processed food exports and imports grew rapidly for both Canada and the U.S. As shown in Figure A, the expansion of trade in processed food increased the total value of agri-food exports, and lowered the proportion of bulk agricultural exports in the make-up of total agri-food exports.

During the same period, there was a change in the mix of farm types. Producers became less reliant on grains and more reliant on specialty crops and intensive livestock farming. As the mix of farm types changed over time, so too did the composition of net cash farm income. For example, direct government payments have declined steadily since 1992, amounting to a smaller and smaller share of net cash farm income. Consequently, many producers became more exposed to market forces, particularly those driven by world markets. As Canada is highly dependent on export markets for agri-food sales, further growth in agri-food output requires new or expanded trading opportunities, bringing with it a higher portion of total income derived from exports.

Sources of Export Growth

There are several possible sources of export growth. Exports of Canadian products can grow for demand-side reasons, such as improved access to foreign markets or a growth in foreign income. Exports can also grow for supply-side reasons, such as productivity growth or a reallocation of resources between sectors in the economy. Each of these sources of export growth leads to different changes in output, input prices, and utilization of factors of production. These changes will, in turn, lead to differences in net cash farm income.

Scenario Results

We conducted a model-based analysis to examine the relationship between the growth in the value of exports and the growth in net cash farm income.⁵ Because this relationship is not unique, we devised two scenarios for which Canadian agri-food export value increased \$1 billion. The first scenario assumed a global expansion of import access through a reduction

in all agri-food tariffs for all countries. The second scenario increased demand for Canadian exports through an exchange rate induced decline in prices of Canadian products relative to those of other countries.⁶ The objective of these two scenarios was to estimate the impact on producers' net cash income as a result of the increase in export value.⁷

With the first scenario, we imposed a worldwide reduction in tariffs on all agri-food commodities of 4% to achieve the \$1 billion increase in export value. This change had only a minimal effect on the world prices of Canadian primary agriculture products which increased an average of 0.3%. Primary agricultural output increased between 2% and 4%. This policy change, however, was sufficient to raise Canadian agri-food exports by \$1 billion and resulted in a \$250 million increase in net cash farm income, a figure representing the share of export revenues which returns to the primary sector.

For the second scenario, a 3% decrease in the real exchange rate was sufficient to increase agrifood exports by \$1 billion. With this scenario, the world price of Canada's exports of primary agricultural products decreased an average of 2%. Primary agricultural output increased between 6% and 9%. The resulting \$1 billion increase in exports of agri-food products yielded a \$310 million gain in net cash farm income.

The results of the two scenarios, while not necessarily based on any anticipated changes in policy, do indicate that for a variety of policy changes resulting in larger Canadian agri-food exports, the impact on net cash farm income is in the range of \$250-\$310 million for each additional \$1 billion in agri-food exports. As numerous factors impinge upon the relation between net cash farm income and the value of agri-food exports, these figures should not be taken as a prediction of the future but more as an indicator of the long-run relationship between the two data series.

The fact that the increase in net cash farm income represents less than 100% of the increased value of exports is no surprise given that net cash farm income incorporates production costs while the value of exports does not. While primary producers may not capture all the benefits, in the long-run they do gain a portion of the returns to the Canadian economy. The remaining

benefits of increased exports dissipate via indirect and induced effects throughout the agrifood sector. Precisely how these benefits are distributed, however, varies according to the source of growth.

For example, increased foreign demand for Canadian livestock promotes growth in this sector and as farmers' output increases so too does the need for inputs such as capital equipment, feed, veterinary services, fertilizers and pesticides. Some benefits of this growth also pass to other agricultural producers, such as grain growers, through increased sales to livestock producers. Downstream sectors such as transportation, processing and manufacturing are also positively affected as requirements for their services grow. Furthermore, part of the labour income generated by the improvement in expansion of the agriculture sector, including the labour income generated in the input sector, the processing sector and at the farm level, is spent within rural communities. This transfer, in turn, enhances the viability of rural communities.

Conclusion

This analysis shows that an increase in the value of Canadian agri-food exports benefits farmers in the form of increased Canadian net cash farm income and also benefits other segments of the Canadian economy. In particular, our analysis shows that for two hypothetical 'events' on world markets, between about 25% and 30% of a \$1 billion increase in the value of Canadian agri-food exports is passed on to Canadian farmers in the form of net cash income.

The analysis also shows that the increase in the value of agri-food exports throughout the 1990s was largely a result of value-added commodities. Though bulk exports continued to grow at a slower rate, domestic sales to processors increased due to increased foreign demand. The benefits of these sales extend both upstream and downstream from primary agriculture production. By increasing agri-food exports, the whole economic infrastructure surrounding agricultural activity stands to benefit, both on the farm, in the community and across the country.


