## **Rebates offered for switching to high-efficiency furnaces**

**Calgary – June 30, 2005** -- A new rebate program will help Albertans save money and energy when they buy an energy efficient furnace this year.

Alberta's Climate Change Central and Natural Resources Canada are offering a timelimited cash rebate to Albertans who buy an ENERGY STAR<sup>®</sup>-qualified gas furnace.

"This rebate program shows that by partnering with the province and industry, we can deliver excellent initiatives to consumers, which will help them achieve their One-Tonne Challenge goals," said the Honourable Anne McLellan, Deputy Prime Minister and Regional Minister for Alberta, on behalf of the Honourable R. John Efford, Minister of Natural Resources Canada.

Homeowners can receive up to \$300 in rebates when replacing their old furnace with a new, ENERGY STAR-qualified furnace. Manufacturers may supplement the rebate with offers of their own. The time-limited program begins July 4, 2005. Rebates will be reserved on a first-come, first-served basis.

"The success of our 2004 furnace replacement program demonstrated that Albertans can have a positive impact on the environment while saving money," said Simon Knight of Energy Solutions Alberta, energy efficiency office of Climate Change Central.

The rebate applies to the replacement of an older furnace with an ENERGY STARqualified, high-efficiency gas furnace or boiler, which can improve the average efficiency of a typical home's heating system by 30 per cent, and save the consumer about \$400 a year.
