Fact Sheet: Response Statements

Where species are endangered or threatened, governments have an obligation to help them recover. Recovery is a challenging process that requires the full support of all levels of government, the scientific community and most importantly the people who use the land and waters where species are found. By using the best available scientific, community and Aboriginal traditional knowledge, and by engaging the cooperation of landowners and stakeholders, it is possible to help species recover.

Response statements are a means of kick-starting the national recovery process for species that have been newly designated as *threatened*, *endangered* or *extirpated* (no longer present in Canada, but found elsewhere) by the Committee on the Status of Endangered Wildlife in Canada (COSEWIC). They represent a new step in the national recovery process developed under the *Accord for the Protection of Species at Risk in Canada*. The *Accord*, agreed to by the federal government, the provinces and the territories, lays out a number of joint commitments to protect species at risk.

Response statements are designed to show the immediate action that governments propose to take to protect and recover *endangered* and *threatened* species found within their jurisdiction. They are also prepared for species designated by COSEWIC as *extirpated*.

Response statements include a description of immediate conservation and protection measures, and preliminary recovery information including the recovery approach. They also identify the lead and other responsible jurisdictions for each species.

Soon after the designation of new species by COSEWIC, relevant jurisdictions work collaboratively, aided by the Recovery Secretariat at Environment Canada, to identify the lead and other responsible jurisdictions that will be involved in the development of the response statements.

Response statements have been released for the following 32 species designated as *endangered*, *threatened* or *extirpated* by COSEWIC at its meetings in May 2001 and November 2001.
