Influence of Capital Markets on the Supply Chain: Building the Better Business Model



Tony is Manager, Fleet & Operational Assets & Major Projects at Canada Post Corporation in Ottawa. His extensive experience includes development and project management of On Board Computer Technology for delivery vehicles; Hybrid Electric Vehicles which reduce emissions and fuel consumption, in addition to numerous other environmentally focused initiatives. Tony's introduction to the supply chain and transportation logistics industry was as a warehouseman at a courier company in Toronto.
