

Executive Summary

In keeping with its ongoing commitment to involve citizens in decision-making, the City of Kelowna undertook its 9th annual Citizen Survey in July of 2005. Survey results are used to identify residents' satisfaction with existing programs and services, determine the priorities for budget decisions and to identify trends that have evolved since the first survey was conducted in 1995.


A mail-out survey was sent to a random sample of 2500 Kelowna residents and 923 surveys were completed, giving a response rate of 37%. The geographic distribution of the sample was 31% from *Mission/S.E. Kelowna*; 22% from *Central Kelowna*; 24% from *Rutland/Black Mountain*; and 23% from *Glenmore/Dilworth/McKinley/Ellison*. The following report summarizes this year's results and provides comparisons with previous years when applicable.

Traffic Congestion: Single Most Important Issue Facing the City of Kelowna




The majority of respondents (43%) continue to feel that the most important issue facing the City of Kelowna over the next 5 years involves *Roadways and Transportation*. Specifically, 31% of respondents cited issues related to *traffic congestion*. The number of respondents who feel issues related to *Planning and Development* and *Protective Services* are most important has increased for the past 3 years.

Residents are Satisfied with City Services



Respondents were asked to rate their overall satisfaction with the level and quality of services provided by the City of Kelowna. 91% of respondents were somewhat or very satisfied, a relatively high ranking. In a March 2004 Ipsos Reid survey conducted for several other BC municipalities, 82% of respondents indicated they were satisfied with the services of their municipality.

Overall Satisfaction with Each City Department




Respondents were asked to provide their overall level of satisfaction with each of the City Departments.

Parks, Leisure and Cultural Services received the highest overall satisfaction ratings with 94% somewhat or very satisfied. Protective services was second with 90% satisfaction. Both have dropped slightly from previous years.

The satisfaction level for Roadways and Transportation Services continues to decrease.


Significant Changes in Satisfaction

The section below highlights the most significant changes in satisfaction levels. Satisfaction ratings were calculated by adding *somewhat satisfied* and *very satisfied*.




Roadways & Transportation:

Satisfaction ratings for *road network/traffic circulation* received a 42% satisfaction rating in 2005, down 3% from 2004 and 14% from 2003.




Satisfaction with the number of bicycle lanes has increased by 13% since 1998.




Environmental Services:

Drinking water quality received a 59% satisfaction rating in 1998 and a 78% satisfaction rating in 2005.



Parks, Leisure & Cultural Services:

Satisfaction levels for the condition of beach parks dropped significantly in 2005.



Communication and Public Consultation:

Satisfaction levels for *staff customer service* have shown slight increases each year since 1998.

Introduction

The City of Kelowna has conducted comprehensive Citizen surveys on a yearly basis since 1998. Each year residents of Kelowna have been asked to rate their level of satisfaction with a variety of City services and programs. The survey is an important step in the process to include input from the citizens of Kelowna in the City's operational, service and budgeting decisions for the upcoming year.

Discovery Research, an independent consulting firm, was retained to conduct the 2005 Citizen Survey. This report provides detailed results from this year's survey and makes comparisons with previous research when applicable. The survey was designed so that citizens' opinions could be easily summarized and prioritized.

Objectives

The 2005 Citizen Survey has the following objectives:

- > Measure citizens satisfaction levels with the various City services
- > Determine the public's views as to the types of changes needed in City services
- > Identify areas for improvement
- > Determine year-to-year changes (trends) in the perceived level of service provided by the City
- > Summarize the public's views as to the priority of any future operational or facility improvements.


Methodology

A total of 2500 questionnaires were mailed to households randomly selected from the most current database available from Super Pages List Services (Telus). The random sample was generated such that each household in Kelowna had an equal opportunity of being selected for the research.

Each potential respondent was mailed a package that included a letter from the Mayor on City letterhead, a four-page survey and a postage-paid return envelope (see appendix for examples).

In total **923** surveys were completed and returned, giving a response rate of **37%.** This is an excellent response rate for a mail survey when the industry standard is 14%. Kelowna citizens have shown a genuine interest in shaping Kelowna's future and helping the City of Kelowna with difficult decisions.



This bar graph displays the margin of error associated with various sample sizes.

Statistics generated from the 2005 sample size of 923 will be accurate within $\pm 3.3\%$, at the 95% confidence interval (19 times out of 20).

Weighting

The sample statistics have been weighted to match the age distribution of the entire population of Kelowna. According to the 2001 Census data, Kelowna had the following age distribution:

The 18-24 year old age group was the least likely to complete the survey. Results for the 18-24 year old age group should be interpreted cautiously because this group had a relatively small sample size.

Explanation of Reporting

Several questions on the survey ask respondents to rate their level of agreement or satisfaction on a 4-point scale. Here are some examples of the scales which were used:


Throughout this report the "top 2 box percentage" is used to summarize responses. This refers to the percentage of respondents who checked off either the top box or the second most favourable response.

Section 1 - Roadways and Transportation


Q1. 2005 Roadways and Transportation Satisfaction Ratings



Overall, 76% of respondents were satisfied with the City's Roadways and Transportation services. Street light maintenance (93%), street signage (90%), and street sweeping (89%) received the highest satisfaction ratings.

Citizens were less satisfied with the timing of traffic signals (57%) and road network/traffic circulation (42%).

Yearly Comparison of Roadways and Transportation Satisfaction Ratings



The Overall Roadways and Transportation satisfaction ratings have declined from 86% in 2002 to 76% in 2005.

The rating for the *number of bicycle lanes* has increased by 13% compared to the 1998 rating.

Satisfaction with road network/traffic circulation has decreased by 14% since 2003.




Q4. Considering the City's responsibility for the road network, how satisfied are you with the following:



A small increase occurred in satisfaction levels associated with the City's responsibilities for the road network in 2005.

Satisfaction with *Observance of posted speeds* increased from 51% in 2004 to 60% in 2005.

Q5. Which of the following transportation issues are most important to you?




Respondents were provided with several transportation issues and asked to choose the most important issues.

The two most important transportation issues are *reducing congestion on Hwy 97* and *Okanagan Lake Bridge*. Highway 97 congestion continues to be the top concern while *bridge congestion* is less of a concern than in previous years.


Q6. How important is it for the City to work with other levels of government to plan for a Central Okanagan Bypass highway and a second bridge across Okanagan Lake?

Q7. 2005 Environmental Services Satisfaction Ratings




Environmental Services received an 87% satisfaction rating overall.

Garbage collection services (95%), curbside recycling collection (94%) and recycling depots (94%) had the highest satisfaction ratings.

Air quality (71%) had the lowest satisfaction rating, although showing an increase from 67% in 2004.

Yearly Comparison of Environmental Services Satisfaction Ratings




The overall Environmental Services Satisfaction rating has remained steady at 87%.

Recycling depots satisfaction ratings have increased by 9% since 1998.


Drinking water quality received a 78% satisfaction rating in 2005 compared to 59% in 1998.




Most respondents feel that improving the quality of storm water runoff should be a *medium priority* (54%) for Council.

Over two-thirds (69%) of Kelowna residents would support *a mandatory vehicle emissions program*. Residents who own more vehicles are less likely to support emission testing.

Q13. In the past year has anyone in your household experienced negative health effects due to poor outdoor air quality in your neighbourhood?




25% of respondents had someone in their household *experience negative health effects due to poor air quality, a slight drop from* 2004.

Support for a *bylaw restricting herbicide and pesticide use* has increased from 47% in 2003 to 59% this year, while dropping slightly from 2004.




Q16. 2005 Parks, Leisure and Cultural services Satisfaction Ratings



Respondents were very satisfied with all aspects of Parks, Leisure and Cultural services. The *Mission Softball Complex* received the highest rating with 98% satisfied.

Availability of beach parks received the lowest ratings but still received an 80% satisfaction level. This is a slight drop from 2004's 84%.

Parks, Leisure and Cultural activities received high ratings in all areas.


Satisfaction ratings for availability and condition of arenas have shown considerable improvement from 1998 to 2005.

Availability of sportsfields is showing an increase in satisfaction.

Satisfaction with the availability of cultural activities increased from 74% in 1998 to 90% this year.

Q17. In the past year, which of the following have you visited?




The vast majority of citizens visited *City Park* (87%) or *Waterfront Park* (80%) in the past year.

Mission Creek Greenway was visited by 77% of respondents this year compared to 69% in 2002 showing a consistent rise in popularity.

Sports fields and Ben Lee Park were added to the list of City parks on the 2005 survey.

The majority of respondents (89%) felt that purchasing *natural open spaces and trails* was somewhat or very important.



Younger respondents were significantly more likely to engage in physical activities.


Q20. Do you agree or disagree with the following statements?



91% agree that Kelowna's tourism industry is dependent on our beaches and parks


In 2005, slightly fewer respondents agree that the *parks are clean and well maintained*.

Q21. Which of the following is most important to include in a future facility for senior citizens (over 55 years of age)?




The most popular service is health care and wellness services at 81%. This is followed by social programs and activities (60%) and therapeutic and rehabilitation services (55%).

Four out of five respondents believe the number of dog parks is sufficient.


Q23. Would you support allowing dogs on leash on all clearly defined paths and walkways within City Park and Waterfront Park?



Over half of respondents (53%) would support allowing dogs on leash in City and Waterfront Parks.



Q24. 2005 Planning & Corporate Services Importance Ratings




94% of respondents feel *minimizing urban impact on sensitive natural areas* is very or somewhat important.

87% feel it is important to minimize urban impact on agricultural areas.




Planning and Corporate Services' importance ratings have remained consistent since 2003.

Q25. Are you considering moving to a different location in Kelowna in the next 5 years?




Thirty-seven percent are considering *moving*.




Among residents living in Central Kelowna, 51% are planning to move to a single family dwelling. Among residents living in Rutland/Black Mountain, 75% wish to move to a single-family dwelling.





Q31. How often do you buy bottled water for drinking?




In 2005, 26% of respondents always buy bottled water for drinking, a decrease from 35%. There were no significant differences between water supplier and the frequency of bottled water purchases.

Q32. Would you be prepared to pay higher water rates to reduce the risk of water-borne disease outbreaks?




63% would pay higher water rates.

Q33. How important is water conservation within our community?




Water conservation is considered *very important* or important by 96% of respondents.

Q35. If 'YES' – What steps have you taken to reduce water consumption?




65% of respondents use less water inside the home and 55% changed their irrigation system or water their yard less at home.

Most water consumption reduction efforts are made at home and not work.










Q45. 2005 Protective Services Satisfaction Ratings



Yearly Comparison of Protective Services Satisfaction Ratings







Q47. Have you ever used a Community Policing Office?











Q51. How safe is Kelowna?










Yearly Comparison of Other Services Satisfaction Ratings








Q61. Would you like to see increased funding for any of the following?


Q62. Please indicate the level of support the City should provide in developing tourism in the following areas:


Q63. If faced with the following choices, which direction would you want City Council to take over the next year?



Q64. If faced with the following choices, which direction would you want City Council to take over the next year?










