SELECTION CRITERIA

Eligibility

The Award is presented every year in conjunction with the Mayor's Environmental Expo to individuals or groups who have made outstanding or innovative contributions to the protection or management of the environment. Candidates can be associated with any field or aspect of the environment. Those eligible to make nominations must be residents of the Central Okanagan. Nominees for individual category awards must live in the Central Okanagan. Nominees for group, business or classroom awards may be of any size (small or large) and must operate, or be located, within the Central Okanagan.

Length of Candidacy

Nominees may be received for consideration on an annual basis. A new letter of nomination and updated description of achievements is required each year.

Nomination Procedures

Identify nominee by completing the nomination form. Include name, mailing address, phone number (and/or FAX), date, and nomination category.

Summary of accomplishments

Provide a summary of the individual or group achievements in the field(s) for which the award is proposed. Be precise and factual.

Provide a detailed explanation of the environmental achievement and explain why it is valuable and worthy of recognition. Describe how each achievement was accomplished. Mention any significant involvement of others.

Deadline for nominations

Nominations for the award, information in support of the nomination and nomination form must be received **no later than May 5, 2006**.

Nominations can be dropped off, mailed, or faxed to the City of Kelowna Environment Division.
