## <u>Presentation of the Initiatives to the Champions who were unable to attend the Ste-</u> Adèle Retreat on September 26 and 27, 2002

Educating Public Service Managers: better equip them in the area of official languages.

Team members: Sandra Webber and Yolande Cloutier.

Persons in charge: Dawn Edlund and Mario Dion.

Presenter: Lise Cloutier, replacing Mario Dion of the Department of Justice Canada.

Three training sessions on language of work have been given, and ten more sessions are to come. The process followed is:

- √ A letter is sent to the members of the Department of Justice executive committee offering them a training session in the area of the official languages.
- √ Training sessions are given on language of work in terms of managers' obligations and employees' responsibilities. Also, profiles of each division are prepared on the basis of the recent data from a survey on the official languages, and examples of what could be done are proposed.
- $\sqrt{}$  The Person Responsible for Official Languages also offers tools to the managers on an individual basis e.g.: how to hold bilingual meetings.
- $\sqrt{}$  One year later, the progress is measured using the data from a second survey on the official languages.

**Social marketing**: identify ways to promote official languages as a fundamental value in departments and agencies.

# Creation of the Council of the Network of Departmental Official Languages

- √ The advisability of officially establishing the Council will be on the agenda for the Edmonton meeting next February; this item will also include a presentation on the work done by each of the working groups formed in Ste-Adèle.
- √ Topics discussed at the meeting on November 21, 2002: mandate and role of the Council; financial support; work plan; Edmonton conference and *Strategy for Action*. Full report of meeting.
- $\sqrt{}$  A third meeting is to be held on January 30, 2003.

Active presence of the Champions on departmental executive committees: better ensure leadership in the area of the official languages.

- √ A second conference call will be held in late January 2003 so that the working group members can approve the letter.
- √ The letter will be sent to the deputy ministers once the working group members approve it.

Wealth of Cultural Diversity Underlying Bilingualism: enhance the appreciation of the cultural aspect of language learning.

Liaison with the members of the National Joint Council's Official Languages Committee: inform the members of the National Joint Council's Official Languages Committee on the Champions' role in the departments and the results of the retreat in Ste-Adèle.

√ Diana Monnet and Michel J. Cardinal will make a presentation on February 4, 2003, to the members of the National Joint Council's Official Languages Committee on progress in the initiatives arising out of Ste-Adèle.

Redesign of the Publiservice site of the Treasury Board Secretariat's Official Languages Branch: highlight the departmental Champions' sub-site, add more tools and permit information management in support of the Champions' role.
