## Mr. Jim Carter

**President and Chief Operating Officer of Syncrude Canada** 



The Alberta Chamber of Resources' Resource Person of the Year award was presented to James (Jim) Carter, President and COO of Syncrude Canada Ltd. for his many years of service and leadership in the industry. Mr. Carter was recognized for his contri-

butions to responsible resource development in Alberta that have improved environmental performance, increased workplace safety, advanced technical and scientific knowledge, strengthened relations with Aboriginal stakeholders and boosted the industry's capacity to meet its need for highly skilled human resources. He was also cited for his extensive community volunteer work. From 2002 to 2004 he served as Chairman of the Mining Association of Canada, during which time the Association introduced a sweeping set of environmental and social performance criteria to align the actions of the mining industry with the priorities and values of Canadians.

Mr. Carter has been associated with the Alberta Chamber of Resources for many years. He has served as a Director and Member of the Executive Committee, and he spearheaded a 1992 Chamber initiative to save the University of Alberta's School of Mining, which faced closure due to declining student enrolment and imminent faculty retirements. Today, the school is one of the largest and most respected of its kind in North America, and Mr. Carter continues to serve as Chair of its Industry Advisory Committee. Mr. Carter also championed such recent Chamber initiatives as the Oil Sands Technology Roadmap and the Aboriginal Programs Project.

Jim Carter was appointed President and Chief Operating Officer of Syncrude in October 1997.

Mr. Carter began his career with Syncrude in 1979 as Manager of Overburden Operations where he introduced the Syncrude-owned truck-and-shovel overburden removal fleet. In 1981, he was appointed Assistant General Manager of Mining, responsible for the overburden, tailings and mine


