## UNDERTAKING AND ACKNOWLEDGEMENT

**Limited Disclosure** 

IN THE MATTER OF an inquiry under the *Special Import Measures Act* respecting the dumping in Canada or subsidizing of

(c) not to reproduce, in any manner, information disclosed to me under the conditions of this undertaking;

(*d*) to keep confidential and to protect the information disclosed to me under the conditions of this undertaking in the following manner, namely:

(i) I will keep in my office or under my control, at all times, all information made available to me under the conditions of this undertaking, and

(ii) I will store all materials containing information disclosed under the conditions of this undertaking in a locked vault, safe or other secure storage place when the materials are not being used;

(e) to return to the Secretary, under the direction of the Secretary, all materials containing information disclosed under the conditions of this undertaking, at the end of my participation in the proceeding; and

(f) to report promptly to the Canadian International Trade Tribunal any violation of this undertaking.
