CALL FOR SUBMISSION OF CATEGORY A TRADE IRRITANTS

In November, 1997, the Food Residues Subcommittee of the NAFTA Technical Working Group (TWG) produced a draft document entitled "*Procedures for the Identification and Resolution of NAFTA Pesticide Trade Irritants*", in which several categories of trade irritants, with procedures for resolving each type of trade irritant, were defined . Version 2 of this document was released December 18, 1998 and is available electronically on the EPA and PMRA websites¹.

An integral part of the procedure is the identification of Category A trade irritants². Member countries under NAFTA have agreed to set aside resources to resolve Category A trade irritants through the Food Residues Subcommittee. The NAFTA member pesticide regulatory agencies will make an effort to schedule work on as many of these trade irritants as resources permit. Category A trade irritants will be prioritized so that, if the member regulatory agencies do not have sufficient resources to handle resolution of all trade irritants, the agencies can schedule work on those trade irritants with the highest priority first.

In order to be considered for prioritization this year, all proposed Category A trade irritants must be received by one of the co-chairs of the Food Residues Subcommittee no later than April 30, 2000.

² A Category A trade irritant is defined as a discrepancy arising when an MRL/tolerance has been established in the exporting country, but it is lower or does not exist in the importing country, and the product has been documented to be out of compliance in the importing country.
