User Requested Minor Use Label Expansion Program Registrations for June 1 - September 30, 2000

The User Requested Minor Use Label Expansion (URMULE) Update provides timely information on the latest proposals for minor use label expansion of pesticides that have been evaluated and accepted for registration.

For the following pesticides, a Certificate of Registration has been issued based on a Supplemental Label, making the use legal. Registrants are required to add the new use to the full product label at the next printing. Provincial authorities, in publishing recommendations on the use of agricultural chemicals, may incorporate such acceptable uses in the knowledge that they meet the requirements of the *Pest Control Products Act*. Users must consult the product label as the ultimate authority on whether or not the product can be used to control a specific pest on a specific site, as a product's uses are subject to change.

Vegetables

Imidacloprid (Admire 240F – Bayer) Registration number 24094 for the control of lettuce aphid on lettuce in Nova Scotia.

Tebufenozide (Confirm240F – Rohm&Haas) Registration number 24503 for the control of European corn borer on greenhouse pepper.

Myclobutanil (Nova 40W – Rohm&Haas) Registration number 22399 for the control of powdery mildew on greenhouse peppers.

Pyridaben (Dynomite – Plant Products) Registration number 25229 for the control of two spotted spider mite on greenhouse cucumber.

Nicosulfuron (Accent – DuPont) Registration number 25116 for weed control on listed sweet corn varieties and seed corn hybrids.

Fruit

Fluazifop-*p***-butyl** (Venture L – Zeneca) Registration number 21209 for the control of annual grasses on lowbush blueberry in the fruiting year.

Field Crops

Propiconazole (Tilt 250 – Novartis) Registration number 19346 for the control of frog eye leaf spot, and aerial web blight on soybean grown for seed.

Ornamentals

Tebufenozide (Confirm 240F – Rohm&Haas) Registration number 24503 for the control of listed insects on greenhouse ornamentals.
