



## **User Requested Minor Use Label Expansion Program Registrations for October 1, 2000 – February 28, 2001**

The User Requested Minor Use Label Expansion (URMULE) Update provides timely information on the latest proposals for minor use label expansion of pesticides that have been evaluated and accepted for registration.

For the following pesticides, a Certificate of Registration has been issued based on a Supplemental Label, making the use legal. Registrants are required to add the new use to the full product label at the next printing. Provincial authorities, in publishing recommendations on the use of agricultural chemicals, may incorporate such acceptable uses in the knowledge that they meet the requirements of the *Pest Control Products Act*. Users must consult the product label as the ultimate authority on whether or not the product can be used to control a specific pest on a specific site, as a product's uses are subject to change.

### **Sethoxydim** (Poast Ultra – BASF)

Registration number 24835 for post-emergent grass control in Field Peppers.

### **Quizalofop-*p*-ethyl** (Assure II – DuPont)

Registration number 25462 for post-emergent control of grasses in Snap Beans.

### **Fomesafen** (Reflex – Zeneca)

Registration number 24779 for weed control in Lima Beans.

### **Abamectin** (Avid 1.9% – Novartis)

Registration number 24485 for the control of leafminers (*Liriomyza* spp.) in Greenhouse Cucumbers and Greenhouse Tomatoes.

## Fruit

### **Abamectin** (Agri-Mek 1.9%EC – Novartis)

Registration number 24551 for the control of Spotted Tentiform Leafminer in Apples.

## Field Crops

### **Quinclorac** (Accord DF – BASF)

Registration number 25118 as a tankmix with Buctril M plus Merge for the control of listed weeds and suppression of annual and perennial sowthistle in Canaryseed.

### **Bromoxynil** (Pardner – Rhone-Poulenc)

Registration number 18001 for labelled weed control in Forage Sorghum and Forage Millet.

### **Dimethenamid** (Frontier – BASF)

Registration number 23462 for the control of labelled weeds in inbred lines of Seed Corn grown in Southern Ontario ONLY.

## Ornamentals

### **Cyhalothrin-lambda** (Matador – Zeneca)

Registration number 24984 for the control of listed insect pests in Chokecherry Shelterbelts.

### **Benzyladenine:Gibberellins** (Promalin – Valent Biosciences)

Registration number 16636 for the reduction of leaf yellowing and bud abortion in Lilies.

## Other

### **Fluazifop-*p*-butyl** (Venture L – Zeneca)

Registration number 21209 for weed control in Ginseng.
