

URMULE UPDATE

User Requested Minor Use Label Expansion (URMULE) registrations January 1, 1998 - February 27, 1998

The URMULE Update provides timely information on the latest proposals for minor use label expansion of pesticides that have been evaluated and accepted for registration.

For the following pesticides, a Certificate of Registration has been issued based on a Supplemental Label, making the use legal. Registrants are required to add the new use to the full product label at the next printing. Provincial authorities, in publishing recommendations on the use of agricultural chemicals, may incorporate such acceptable uses in the knowledge that they meet the requirements of the Pest Control Products Act.

HORTICULTURE CROPS AND PRODUCTS

Tree Fruits

Fosetyl-Al (Aliette-Rhone-Poulenc), registration number 24458 for blister spot control on apples.

Small fruits

Tribenuron Methyl (Spartan - DuPont), registration number 23632 as a spot treatment for the control of yellow loosestrife, speckled alder, braken fern and wild rose on lowbush blueberry.

Napropramide (**Devrinol- Zeneca**), registration number 22885 as a tankmix with **simazine** for weed control on newly-planted strawberry (BRITISH COLUMBIA ONLY).

Vegetables

Metribuzin (**Sencor - Bayer**), registration number 14876 with EPTAM for weed and grass control applied through irrigation systems on potatoes.

Iprodione (Rovral-Rhone-Poulenc), registration number 15213 for the control of seedborne alternaria on imported carrot seed.

Napropamide (Devrinol-Zeneca), registration number 20123 for weed control on garlic and peppers.

SPECIALTY CROPS

Benomyl (**BenlateWP - Dupont**), registration number 11062, for green mold control on mushrooms.

Bacillus thuringiensis serotype H-14 (Vectobac 600L - Abbott), registration number 19455 for the control of fungus gnats on greenhouse ornamentals.

Cypermethrin (Cymbush 250-Zeneca), registration number 19170 for cutworm control on stevia.

ORNAMENTALS

Mancozeb (Dithane DG-Rohm&Haas), registration number 20553 for honeysuckle blight control on honeysuckle.

FORAGE GRASSES

MCPA, mecoprop, dicamba (Target-Novartis), registration number 13761 for broadleaf weed control on established forage grasses.

FORESTRY

Bacillus thuringiensis kurstaki (Foray 48B white tussock moth in conifers.	- Abbott), registration	on number 24977, f	or the control of
