



## URMULE Update

### **User Requested Minor Use Label Expansion (URMULE) Registrations May 1, 1998 - May 31 1998**

The URMULE Update provides timely information on the latest proposals for minor use label expansion of pesticides that have been evaluated and accepted for registration.

A Certificate of Registration, based on a supplemental label, has been issued for the following products, thereby legalizing the use. Registrants are required to add the new use to the full product label at the next printing. Provincial authorities may incorporate such acceptable uses in publishing recommendations on the use of agricultural chemicals with the knowledge that they meet the requirements of the *Pest Control Products Act*.

## Horticulture Crops and Products

### Vegetables:

**Napropamide (Devrinol 50 DF - Zeneca)**, registration number 22885. For weed control on Chinese cole crops, Chinese broccoli, Chinese mustard cabbage, Chinese radish, kohlrabi and Chinese cabbage (Nappa cabbage).

**Fosetyl-Al (Aliette WDG - Rhone-Poulenc)**, registration number 24458. For downy mildew and purple blotch control on onions and downy mildew control on lettuce.

**Bacillus thuringiensis (Vectobac 600L - Abbott)**, registration number 19455. For the control of fungus gnats on greenhouse vegetables and herbal bedding plants.

### Grasses Grown for Seed:

**Metsulfuron-methyl (Ally Herbicide - Dupont)**, registration number 24388. For the control of weeds on established creeping red fescue grown for seed.

**Thifensulfuron-methyl and tribenuron-methyl (Refine Extra - Dupont)**, registration number 22575. For weed control on 13 listed grass species grown for seed production and forage.

### Field Crops:

**Quizalofop-ethyl (Assure Herbicide - DuPont)**, registration number 22111. For annual grass and volunteer cereal control on sugarbeets.

**Ethametsulfuron-methyl (Muster Herbicide - DuPont)**, registration number 23569. For wild mustard control on canola grown in the Maritimes and Quebec.

### Other Crops:

**Bacillus thuringiensis (Foray 48BA - Abbott)**, registration number 24978. For the control of whitemarked tussock moth on urban ornamental trees.
