

URMULE UPDATE

User Requested Minor Use Label Expansion (URMULE) Registrations April 1-May 30th

To provide more timely information on the latest proposals for minor use label expansion of pesticides that have been evaluated and accepted for registration, the PMRA will send out an **URMULE UPDATE** on a regular basis.

For the following pesticides, a Certificate of Registration has been issued based on a Supplemental Label, making the use legal. Registrants are required to add the new use to the full product label at the next printing. Provincial authorities, in publishing recommendations on the use of pesticides, may incorporate such acceptable uses in the knowledge that they meet the requirements of the *Pest Control Products Act*.

Horticulture Crops and Products

Vegetables

Chlorothalonil (Bravo 500 - ISK), registration number 15723 as a tank mix with **metribuzin**(Lexone DF, PCP 15959) for weed and disease control on Processing Tomatoes.

Rimsulfuron (Prism - DuPont), registration number 23983 for weed control on irrigated potatoes in Western Canada (MB,SK,AB,BC)

Propiconazole (Topas - Engage), registration number 24030, for the control of foliar diseases in Field Corn.

Deltamethrin (Decis 5EC 0 AgrEvo), registration number 22478, for the control of Onion Thrips in Onions.

Legumes Grown for Seed

Bentazon (Basagran - BASF) registration number 12221, for weed control in established Alfalfa grown for seed.

Grasses Grown for Seed

Glufosinate ammonium (Harvest 15SN - AgrEvo), registration number 23179 for the desiccation of Alfalfa grown for seed.

Fenoxaprop-pethyl, MCPA and Thifensulfuron methyl (Triumph Plus - AgrEvo), registration numbers 22348 and 21645 for weed control on Seedling Tall Wheatgrass, Intermediate Wheatgrass, Tall Fescue, Creeping Red Fescue, Smooth Bromegrass and Meadow Bromegrass grown for seed.

Grasses Grown for Forage

Fenoxaprop-pethyl, MCPA and Thifensulfuron methyl (Triumph Plus - AgrEvo), registration numbers 22348 and 21645 for weed control on Seedling Tall Wheatgrass and Tall Fescue grown for forage.

Oilseed Crops

Clopyralid (Lontrel 360 - Dow Elanco), registration number 23535 for the control of Canada Thistle, Wild Buckwheat, Scentless chamomile, Common Grounsel and Perennial Sow-thistle in nationally registered spring Canola cultivars (ONTARIO ONLY) - Ebony, Jewel, Cyclone, Hyola 401 and 46A65.

Cereal Crops and Products

Imazamthabenz (Assert 300SC - Cyanamid), registration number 21032 for the control of Wild Oats in Spring Wheat and Spring Barley in the Okanagan and Creston Flats areas of British Columbia

Other Crops

Clopyralid (Transline - DowElanco), registration number 24085 for the control of Spotted and Diffuse Knapweed.

Forestry

Permethrin (Ambush 500EC - Zeneca), registration number 14882 for Spruce Budmoth, Hemlock Looper and Gypsy Moth control on Spruce, Hemlock, Conferous and Deciduous Trees in Commercial Woodlands not to exceed 500 ha.
