

# **URMULE UPDATE**

# **User Requested Minor Use Label Expansion (URMULE)** Registrations June 1 - July 31th

The URMULE Update provides more timely information on the latest proposals for minor use label expansion of pesticides that have been evaluated and accepted for registration.

For the following pesticides, a Certificate of Registration has been issued based on a Supplemental Label, making the use legal. Registrants are required to add the new use to the full product label at the next printing. Provincial authorities, in publishing recommendations on the use of pesticides, may incorporate such acceptable uses in the knowledge that they meet the requirements of the *Pest Control Products Act*.

#### **Tree Fruits**

**Copper Sulfate**(Copper 53W - United AgriProducts), registration number 9934 for the control of Apple Blister Spot on Mutsu(Crispin) and other sensitive cultivars

**Pirimicarb** (Pirimor 50DF - Zeneca), registration number 22792 for the control of Green Peach Aphid on Peaches

#### **Small Fruits**

**Trichlorfon** (Dylox 420 - Bayer), registration number 16378, for the control of Adult Blueberry Fleabeetle and Blueberry Spanworm on Lowbush Blueberry

**Propiconazole** (Topas 250E - Engage), registration number 24030, for the control of Entomosporium Leaf and Berry Spot on Saskatoonberry.

**Fosetyl-Al** (Aliette WDG - Rhone-Poulenc), registration number 24458 for the control of Phytophthora Root Rot on Red/black Raspberry and Blackberry

### Vegetables

**Myclobutanil** (Nova 40W - Rohm&Haas), registration number 22399, to reduce the PHI from 14 dayts to 3 days on Greenhouse Tomatoes

**Metalaxyl** (Ridomil 240 EC - Ciba-Geigy), registration number 17274 to control Damping Off in Cucumbers

**Sulphur** (Microscopic Sulphur - Bartlett), registration number 00873, for the control of Powdery Mildew on Greenhouse Tomatoes.

**Napropramide** (Devrinol 50DF - Zeneca), registration number 22885 for the control of labelled weeds on Pumpkin and Squash.

**Pendimethalin** (Prowl 400EC - Cyanamid), registration number 23439 for the control of green foxtail, redroot pigweed and lamb's quarters on Dry Bulb Onions in Western Canada.

# Field crops

**Fosetyl-Al** (Aliette WDG - Rhone Poulenc), registration number 24458, for the control of Blue Mold in Flue Cured Tobacco

#### **Grasses Grown for Seed**

**MCPA dimethyl amine** (MCPA Amine 500 - Rhone-Poulenc), registration number 14730 for the control of weeds in Seedling and Established Red Clover for seed production **and** forage.

**Myclobutanil** (Nova 40W - Rohm&Haas), registration number 22399, to control Powdery Mildew on Kentucky Bluegrass grown for Seed

## **Pulse crops**

**Metalaxyl** (Apron FL - Gustafson), registration number 24262 for the control of Pythium Seed Rot on Low Tannin Lentils for seed production and export only.

# **Forestry**

**Glyphosate**( Vision - Monsanto), registration number 19899, for conifer release of summer planted spruce species

**Trichlorfon** (Dylox 420 - Bayer), registration number 16378 for Yellowheaded Spruce Sawfly control on Spruce and Fir forest plantations and regeneration situations.

# Other crops

**Permethrin** (Ectiban 25 - Mallinckrodt), registration number 15701 for the control of mosquitoes on Dairy and Beef Cattle.
