

# **Regulatory Decision Document**

## RDD2004-02

### Saber Insecticide Ear Tags

The end-use product Saber Insecticide Ear Tags (containing 10% w/w lambda-cyhalothrin) for control of horn and face flies on beef and non-lactating dairy cattle is eligible for full registration under Section 13 of the Pest Control Products (PCP) Regulations.

This product was proposed for registration in the Proposed Regulatory Decision Document (PRDD), <u>PRDD2004-02</u>. This Regulatory Decision Document (RDD) outlines this stage of the Pest Management Regulatory Agency's (PMRA) regulatory decision-making process concerning the use of lambda-cyhalothrin for the control of horn and face flies.



#### 1.0 Introduction

This RDD outlines this stage in the PMRA's regulatory decision-making process concerning the use of Saber Insecticide Ear Tags, containing the active ingredient lambda-cyhalothrin, for the control of horn and face flies on beef and non-lactating dairy cattle.

#### 2.0 Background

The PMRA carried out an assessment of available information in accordance with Section 9 of the PCP Regulations. The assessment found that there was sufficient information, pursuant to Section 18(b), to allow a determination of the safety, merit and value of the formulated end-use product Saber Insecticide Ear Tags manufactured by Schering Plough Animal Health. The PMRA concluded that the use of Saber Insecticide Ear Tags in accordance with the label accompanying the product has merit and value consistent with Section 18(c) of the PCP Regulations and does not entail an unacceptable risk of harm under Section 18(d).

This product was proposed for registration in PRDD2004-02, *Lambda-cyhalothrin Saber Insecticide Ear Tags*. The PMRA received no public comments concerning this PRDD.

#### 3.0 Regulatory Decision

Based on the considerations outlined above, the end-use product Saber Insecticide Ear Tags (containing 10% w/w lambda-cyhalothrin) for control of horn and face flies on beef and non-lactating dairy cattle is eligible for full registration, pursuant to Section 13 of the PCP Regulations.
