Triticonazole Charter Seed Treatment Charter PB Seed Treatment

The active ingredient triticonazole and the associated end-use products Charter Seed Treatment (contains triticonazole as active ingredient) and Charter PB Seed Treatment (contains triticonazole and thiram as active ingredients) for the control of selected diseases caused by fungal pathogens on wheat, barley and oats are eligible for full registration of the Pest Control Products (PCP) Regulations. This decision is consistent with the proposal in the Proposed Regulatory Decision Document PRDD2004-06, *Triticonazole*.

1.0 Introduction

This Regulatory Decision Document completes the Pest Management Regulatory Agency's (PMRA) regulatory decision-making process concerning the use of Charter Seed Treatment (contains triticonazole as active ingredient) and Charter PB Seed Treatment (contains triticonazole and thiram as active ingredients) for the control of selected diseases caused by fungal pathogens on wheat, barley and oats.

2.0 Background

The PMRA carried out an assessment of available information in accordance with the PCP Regulations. The assessment found that there was sufficient information to allow a determination of the safety, merit and value of triticonazole and the formulated end-use products Charter Seed Treatment and Charter PB Seed Treatment, manufactured by Bayer CropSciences Inc. in Canada. The PMRA concluded that the use of Charter Seed Treatment and Charter PB Seed Treatment in accordance with the labels accompanying the products has merit and value consistent with the PCP Regulations and does not entail an unacceptable risk of harm.

This product was proposed for registration in the Proposed Regulatory Decision Document PRDD2004-06. No comments were received by the Agency concerning PRDD2004-06.

3.0 Regulatory Decision

Based on the considerations outlined above, the active ingredient triticonazole and the associated end-use products Charter Seed Treatment and Charter PB Seed Treatment for the control of selected diseases caused by fungal pathogens on wheat, barley and oats are eligible for full registration under the PCP Regulations.
