#### 1.0 Introduction

The re-evaluation of the available information for the active ingredient (Z)-9-tricosene, a pheromone used to attract house flies and several other fly species into a trap or to a bait containing insecticide, and the associated end-use products has been completed by the Pest Management Regulatory Agency (PMRA).

## 2.0 Background

The RRD is to notify the registrants, pesticide regulatory officials and the Canadian public that the re-evaluation of (Z)-9-tricosene is now complete.

On 24 October 2003, the PMRA published the Proposed Acceptability for Continuing Registration document <u>PACR2003-12</u>, *Re-evaluation of (Z)-9-tricosene*, for consultation on the proposed regulatory decision for (Z)-9-tricosene. No comments were received by the PMRA concerning <u>PACR2003-12</u>.

This RRD presents the regulatory decisions resulting from the re-evaluation of (Z)-9-tricosene.

## 3.0 Regulatory decision

The PMRA has determined that (Z)-9-tricosene is acceptable for continuing registration provided that the mitigation measures and other requirements specified in <a href="PACR2003-12">PACR2003-12</a> are adequately addressed. End-use products containing additional active ingredients under re-evaluation will be accepted for continued registration only when all the affected active ingredients have been determined acceptable for continued registration.

Registrants are required to amend the labels of pest control products containing (Z)-9-tricosene as described in <u>PACR2003-12</u>. Registrants of end-use products who wish to have their registrations continued should make applications to amend their registrations, through label amendments, in accordance with Section 6.1 of the Pest Control Products Regulations within 90 days of the date of publication of this document.

The registrant of technical grade (Z)-9-tricosene is required to submit the following within 24 months of the date of publication of this document:

- All data (as they relate to the Canadian use pattern) submitted to the United States Environmental Protection Agency (USEPA) in response to the data call-in in the United States prior to the reregistration decision, and associated USEPA Data Evaluation Reports (DERs);
- All data (as they relate to the Canadian use pattern) that were required by the USEPA as a condition for the reregistration of (Z)-9-tricosene.
