



Re-evaluation Decision Document

RRD2004-09

Mecoprop

The purpose of this document is to notify all stakeholders, including the Canadian public, registrants and pesticide regulatory officials, that the re-evaluation of the herbicide mecoprop [2-(4-chloro-2-methylphenoxy) propionic acid] is complete. As a result of this re-evaluation, the technical registrants have decided to discontinue sales of technical racemic mecoprop.

The Pest Management Regulatory Agency (PMRA) is re-evaluating all older pesticide active ingredients and their associated end-use products using modern scientific approaches to determine their continuing acceptability in relation to human health and the environment.

Foreword

In September 2000, the PMRA announced that lawn and turf uses for mecoprop herbicide were being re-evaluated (Re-evaluation Note REV2000-04, *Re-evaluation of Lawn and Turf Uses of Pesticides*). As a result of this re-evaluation, the technical registrants have decided to discontinue sales of technical racemic mecoprop. As a result, all uses of racemic mecoprop and associated salts and esters are to be phased out. While the re-evaluation initially focussed on the lawn and turf uses, the re-evaluation decision presented in this document affects all uses of racemic mecoprop.

1.0 Background

Technical mecoprop, a racemic mixture of 2-(4-chloro-2-methylphenoxy) propionic acid, is registered for weed control on food (e.g., wheat, rye, oats, barley, corn) and feed crops, residential lawns and turf (e.g., golf courses, parks). In September 2000, the PMRA announced that lawn and turf uses for mecoprop herbicide were being re-evaluated (Re-evaluation Note REV2000-04).

2.0 Regulatory decision

During the course of the re-evaluation, the PMRA identified significant data gaps for racemic mecoprop that would have to be addressed in order to bring the supporting database up to modern standards. Rather than generate the required data to support continuing registration, the registrants of technical racemic mecoprop have decided to discontinue sales of the technical active ingredient. While the initial focus of the re-evaluation of mecoprop had been with the lawn and turf uses (Re-evaluation Note REV2000-04), the decision to discontinue registration of the technical active ingredient applies to all uses of mecoprop and associated salts and esters.

The result is that all pest control products containing mecoprop and associated salts and esters are to be phased-out as follows:

- Last date of sale by registrants of manufacturing-use products (technical or manufacturing concentrates) – 31 December 2004.
- Last date of sale by registrants of end-use products – 31 December 2005.

In order to achieve an orderly phase-out of products containing racemic mecoprop, the registrants of the technical active ingredient have agreed to limit sales of the technical active ingredient in 2004 to a maximum of their annual average over the past five years. Beyond 2005, sales of existing end-use products in the possession of those other than the registrant as well as use of end-use product by users is permitted until 31 December 2009 when the registrations will be cancelled.

A list of products registered under the *Pest Control Products Act* that are affected by this decision are presented in Appendix I.

Registrants have expressed the intention to replace the racemic form of mecoprop with a specific isomer of mecoprop known as mecoprop-p. Technical mecoprop-p has recently been reviewed and granted registration by the PMRA. In order to facilitate the transition from racemic mecoprop to mecoprop-p, the PMRA is now prepared to accept applications from registrants to register new products containing mecoprop-p for uses currently registered for racemic mecoprop.
