



Re-evaluation Decision Document

Ancymidol

The purpose of this Re-evaluation Decision Document (RRD) is to notify registrants, pesticide regulatory officials and the Canadian public that the re-evaluation of ancymidol is now complete.

The Pest Management Regulatory Agency (PMRA) has determined that ancymidol is acceptable for continued registration provided that the proposed mitigation measures are adopted and the data requirements are addressed.

This RRD presents the regulatory decisions resulting from the re-evaluation of ancymidol as published in the Proposed Acceptability for Continuing Registration (PACR) document, PACR2004-01, on 19 February 2004.

1.0 Introduction

The re-evaluation of the available information for the active ingredient ancymidol, a plant growth regulator, and its associated uses as a soil drench on container-grown lilies, poinsettias and chrysanthemums, has now been completed by the PMRA.

2.0 Background

The purpose of this RRD is to notify registrants, pesticide regulatory officials and the Canadian public that the re-evaluation of ancymidol is now complete.

On 19 February 2004, the PMRA published PACR2004-01, *Re-evaluation of Ancymidol*, for consultation on the proposed regulatory decision for ancymidol. No comments were received by the PMRA concerning this PACR.

This RRD presents the regulatory decisions resulting from the re-evaluation of ancymidol.

3.0 Regulatory decision

The PMRA has determined that ancymidol is acceptable for continuing registration provided that the mitigation measures specified in the PACR are implemented.

Section 5.0 of the PACR outlined additional requirements for continued registration of ancymidol. Registrants will be informed by letter of the specific requirements and the regulatory options available to comply with this decision.
