GOAL: Develop a residue zone map for North America.

PROJECT DESCRIPTION:

Develop a residue zone map to delineate Mexico's major and minor field trial regions using the Geographic Information System (GIS) which is consistent with criteria used to establish residue zones in Canada and the United States . Once developed, these zones will be folded into Canadian and US zones where ever practical to establish a North American residue map which is mutually accepted by PMRA, EPA and CICOPLAFEST. To the extent possible, the residue map should be harmonized with the NAFTA ecozone map currently being developed by a separate NAFTA project group.

MILESTONES

June 1997 Representatives from CICOPLAFEST and the Mexican pesticide industry

met to discuss the source to finance the project

August 1997 Once financing has been secured, CICOPLAFEST will facilitate a meeting

between Statistics Canada and the Mexican industry to initiate the work

November 2001	Mexican residue zone maps presented at the NAFTA TWG annual full meeting.	
May 2002	Mexican residue zone maps and companion document presented at the NAFTA TWG Executive Board meeting for endorsement. Project is completed.	

BACKGROUND:

Canada and USA have developed a residue map which delineates zones that are unique and which are consistent between the two countries. It was agreed that this map would be extended to Mexico. The North America residue zone map will result in a substantial cost save to industry, in view of the fact that the number of residue trials needed will be reduced and also it will facilitate the development of data in support of major and minor crops and the exchange of residue data reviews.
