THE ACCUSED stands charged:

- 1. THAT it did, between May 23,1991 and November, 1995, the exact dates being unknown, in various locations outside Canada, unlawfully conspire, combine, agree or arrange with F. Hoffmann-La Roche Ltd, BASF Aktiengesellschaft, and Takeda Chemical Industries, Ltd., the one with the other or others of them, together with a person or persons known or unknown, to prevent or lessen, unduly, competition in the production, manufacture, purchase, barter, sale, storage, rental, transportation or supply of a product, namely, vitamin C, in Canada, contrary to paragraph 45(1)(c) of the *Competition Act*, R.S. 1985, c. C-34.
- 2. THAT it did, between October,1991 and September of 1995, the exact dates being unknown, in various locations outside Canada, unlawfully conspire, combine, agree or arrange with F. Hoffmann-La Roche Ltd, Lonza AG, Sumitomo Chemical Co. Ltd., and Tanabe Seiyaku Co., Ltd., the one with the other or others of them, together with a person or persons known or unknown, to

prevent or lessen, unduly, competition in the production, manufacture, purchase, barter, sale, storage, rental, transportation or supply of a product, namely, biotin, in Canada, contrary to paragraph 45(1)(c) of the *Competition Act*, R.S. 1985, c. C-34.
