ON THE APPLICATION OF THE ATTORNEY GENERAL OF CANADA pursuant to section 34 of the Competition Act for an order prohibiting certain conduct of the Respondent, Shake Masters Manufacturing Inc., through James P. Lindemulder;

ON READING THE NOTICE OF CONSENT of the Respondent to the Draft Order;

IT APPEARING that this application is made against Shake Masters Manufacturing Inc., through James P. Lindemulder, pursuant to section 34 of the Competition Act.

#### IT IS HEREBY ORDERED THAT THE RESPONDENT:

- 1. **IS PROHIBITED** from agreeing among any other person from within or without the Province of Alberta:
  - (a) on how to allocate among them Commercial Timber Permits offered for sale by the Alberta Land and Forest Service or by any other seller at an auction, by receipt of closed bids or tenders, or at an open sale, where the agreement or arrangement is not made known to the person calling for or requesting the bids or tenders at or before the time when any bid or tender is made;
  - (b) not to bid or otherwise not to compete with each other in the purchase of Commercial Timber Permits offered for sale by the Alberta Land and Forest Service or by any other seller at an auction, by receipt of closed bids or tenders, or at an open sale, where the agreement or arrangement is not made known to the person calling for or requesting the bids or tenders at or before the time when any bid or tender is made; and
  - (c) to prevent any particular person, being otherwise an eligible buyer of timber, from purchasing Commercial Timber Permits offered for sale by the Alberta Land and Forest Service or by any other seller at an auction, by receipt of closed bids or tenders, or at an open sale, where the agreement or arrangement is not made known to the person calling for or requesting the bids or tenders at or before the time when any bid or tender is made;

- 2. **IS PROHIBITED** from agreeing or arranging among any other person from within or without the Province of Alberta:
  - (a) not to submit a bid in response to a call or request for bids or tenders, where the agreement or arrangement is not made known to the person calling for or requesting the bids or tenders at or before the time when any bid or tender is made; or
  - (b) to submit bids or tenders that are arrived at by agreement or arrangement, where the agreement or arrangement is not made known to the person calling for or requesting the bids or tenders at or before the time when any bid or tender is made.
- 3. **SHALL PROVIDE** a copy of this order and a written statement that it is the policy of the Respondent to comply with the *Competition Act*, in particular with respect to conduct regarding bids as set out herein:
  - (a) within 30 days hereof, to each of its officers and directors, managers, salespersons and purchasers of materials; and
  - (b) within 30 days of their employment, to everyone who becomes employed in any of the foregoing positions.
- 4. **AND IT IS FURTHER ORDERED** that this order is binding upon the Respondent, as well as its successors and their agents and employees.
