AND WHEREAS, the Canada Industrial Relations Board, by order no. 9020-U dated December 29, 2005, certified the Syndicat des employés-es de CKAC-CSN as the bargaining agent for a unit of employees of Les Entreprises Radiomédia Inc. CKAC (C.O.R.U.S.) in Montréal, Quebec;

AND WHEREAS, the Board has received an application, pursuant to sections 44, 45 and 46 of the *Canada Labour Code (Part I -Industrial Relations)*, seeking a declaration that the sale of CKAC (AM) to 591991 B.C. Ltd., subsidiary of Corus Entertainment Inc. constitutes a partial sale of business within the meaning of the *Code*;

AND WHEREAS, the CKAC (AM) radio station was formerly the property of Radiomédia Inc. which was held equally by Astral Media Radio Inc. and Télémédia Communications Inc.;

AND WHEREAS, the certified bargaining agent is not opposed to the present application;

AND WHEREAS, after investigation of the application and consideration of the submissions of the parties concerned, the Board has determined that on October 28, 2002, a sale of business occurred within the meaning of section 44 of the *Code* from Télémédia Communications Inc. to Astral Media Radio Inc. and in May 2005 a partial sale of business occurred within the meaning of the section 44 of the *Code* from Astral Media Radio Inc. to 591991 B.C. Ltd., subsidiary of Corus Entertainment Inc. and that 591991 B.C. Ltd., subsidiary of Corus Entertainment Inc. is the successor employer;

AND WHEREAS, the Board has determined that the provisions of section 44(2) of the *Code* apply and that the Syndicat des employés-es de CKAC-CSN continues to be the bargaining agent of the unit of employees of 591991 B.C. Ltd., subsidiary of Corus Entertainment Inc.;

NOW, THEREFORE, it is declared by the Canada Industrial Relations Board that a partial sale of business has occurred within the meaning of the *Code* and that 591991 B.C. Ltd., subsidiary of Corus Entertainment Inc. is the successor employer, and declares that the Syndicat des employés-es de CKAC-CSN is the bargaining agent for a unit comprising:

"all employees of 591991 B.C. Ltd., subsidiary of Corus Entertainment Inc. working at the CKAC (AM) radio station in Montreal, Quebec, excluding vice-president director general, secretary to the vice-president director general, director of administrative services, assistant controller, production director, program director, marketing director, director of information, sports director, director general of sales, sales director, sales representatives and freelancers."
