## ASSIGNMENT OF LEASE INFORMATION PACKAGE

To process a land lease transfer of interest, the Department of Natural Resources requires the following:

- The transfer document must be prepared in triplicate. It is strongly advised that you seek the assistance of a Solicitor to ensure that you complete the document in accordance with the attached prescribed form with appropriate affidavits, and that your personal interests are protected. **Due to a change in our business practices all leases with partners must be as joint tenants and not as tenants in common.** A sentence reflecting this is in the Assignment of Lease.
- 2) An assignment fee in the amount of \$171.00 (\$150.00 + \$21.00 HST) made payable to the Minister of Finance;
- 3) In the case of an Estate assignment, additional documentation is required:
  - a) A copy of the Death Certificate and a copy of the deceased person's Will (with filing or probate particulars) must accompany the assignment document of the deceased who died with a Will; or
  - b) A copy of the Death Certificate and a notarized affidavit listing all the heirs of the deceased must accompany the assignment document of the deceased who died <u>without a Will</u>;
- 4) Any order of appointment for the administration of the lessee's affairs/estate must accompany the assignment document;
- A copy of minutes authorizing a member(s) to sign on behalf of a non-registered club must accompany the assignment document; otherwise all members must sign the assignment document;
- 6) The authorized signing officers of a corporation must sign the assignment document and provide appropriate corporate affidavit; and
- Proof of payment of the annual lease rental and property taxes in the form of a photocopy of a receipt or cancelled cheque/money order will expedite the approval process.
- 8) A copy of "Schedule A", which is the legal lot description, must be included in the Assignment of Lease. The "Schedule A" is part of the Lease document. If the "Schedule A" is needed, please contact a leasing officer at 1-888-312-5600.

9) Once the Assignment of Lease package is completed, Service New Brunswick requires that Assignment of Leases be registered. For this reason, we require that, in order to conform to registration requirements, all legal documents have margins set at 1½" at the top and 1½" at the left-hand side.
