Class II airports

ü Annual passenger traffic in excess of 200,000 people

- ü Has a medium threat/risk potential or
- ü Is the primary airport of provincial/territorial capital
- ü Is a transit stop for international flights bound for class I or II airports.



Class other airports

Airports with annual passenger traffic less than 200,000 and a low threat/risk potential.

Combined solution

A combined solution refers to an airport security checkpoint that involves both PBS and HBS operations. Combined solutions are typically used at smaller airports with lower traffic volumes and space constraints.
