

Net Fishery Summary - Area 1

Pink

 No net fisheries, surplus harvest opportunities occur only during even years.

Chum

- Gillnet only opportunities provided during 4 days mid September in McIntyre Bay to assess strength of chum salmon migrating into Masset Sound/Inlet. No effort.
- Escapements far below desired target levels.

Net Fishery Summary - Area 2 East

Pink

 No net fisheries, surplus harvest opportunities occur only during even years.

Chum (enhanced)

- Gillnet only opportunities to assess the enhanced Pallant Cr. chums migrating into Cumshewa Inlet occurred September 11 & 12, and 17 & 18.
- These fisheries began one week later than in previous years. This was in response to lower than anticipated returns over recent years.
- A minor surplus harvest opportunity was provided for gillnets only on October 9 & 10.

Net Fishery Summary - Area 2 East (continued)

Chum (enhanced)

- Fleet size ranged from 19 vessels during the stock assessment openings in September to 14 gillnets during the surplus harvest opportunity in October.
- The fishery was serviced by one packer cash buying as well as Omega Packers offloading at Skidegate Landing and Albion/Codfather offloading in Queen Charlotte.
- Approximately 21,000 chum were harvested by gillnets.
- There were no seine fisheries in Cumshewa Inlet.
- Cost recovery harvests occurred September 21 and 22 for approximately 9,600 chum. Results did not indicate a potential surplus of chum in Cumshewa Inlet at the time.

Net Fishery Summary - Area 2 East (continued)

Chum (wild)

- There were no opportunities to harvest wild stock chum salmon in Area 2 East during the 2005 terminal season.
- Chum escapements were very poor in Inlet.
- In Selwyn Inlet, chum returns were near target in Lagoon Creek but less than half of target in most other streams.
- Chum returns were less than half of target to streams in Darwin Sound.
- In Juan Perez Sd. and Skincuttle In. chum escapements were much more abundant than in recent years indicating that stocks may be recovering in the lower south Moresby Island systems.

Net Fishery Summary - Area 2 West

Pink

 No net fisheries, surplus harvest opportunities occur only during even years.

Chum

- Harvest opportunities occurred in Tasu Sound with gillnets only on September 17 & 18, and for both gillnets and seines on September 24 & 25.
- The total gillnet harvest was just over 18,000 chum.
- The total seine harvest was approximately 66,000 chum.

Net Fishery Summary – Area 2 West

Tasu Sound Chum - continued

- Non-retention of coho was in effect.
- The fishery on September 17 & 18 resulted in only 6 coho encounters.
- The fishery on September 24 & 25 resulted in approximately 1,000 coho encounters.
- Additional fishing opportunities were not considered mostly due to concerns regarding coho encounters and mortalities.
- There were no other terminal chum salmon surpluses identified throughout Area 2 West.

 - Very poor returns resulting in minimal harvest opportunities.
- Sockeye 8,000 interception (Langara)
- Coho 950 interception
- Pink 1,000 interception

- Sockeye 123 terminal (Copper)
 - There was no community fishery, harvest was for biological sampling.
- Sockeye 5,000 interception (Rennell Sound)
