## About H.C.S.P.

The Habitat Conservation and Stewardship Program (HCSP) represents a proactive approach to habitat protection that focuses on developing local capacity in habitat conservation and stewardship. The Program has established a network of Stewardship Coordinators, Habitat Auxiliaries and Habitat Stewards across the Pacific Region who will support, advise, and work closely with community watershed stewardship groups, First Nations, developers, industry, other stakeholders and government agencies.

The Program is intended to protect fish habitat through advancing sustainable land and water use planning, promoting better land and water use practices and increasing community advocacy and capacity with respect to the protection of fish habitat.

## About the People

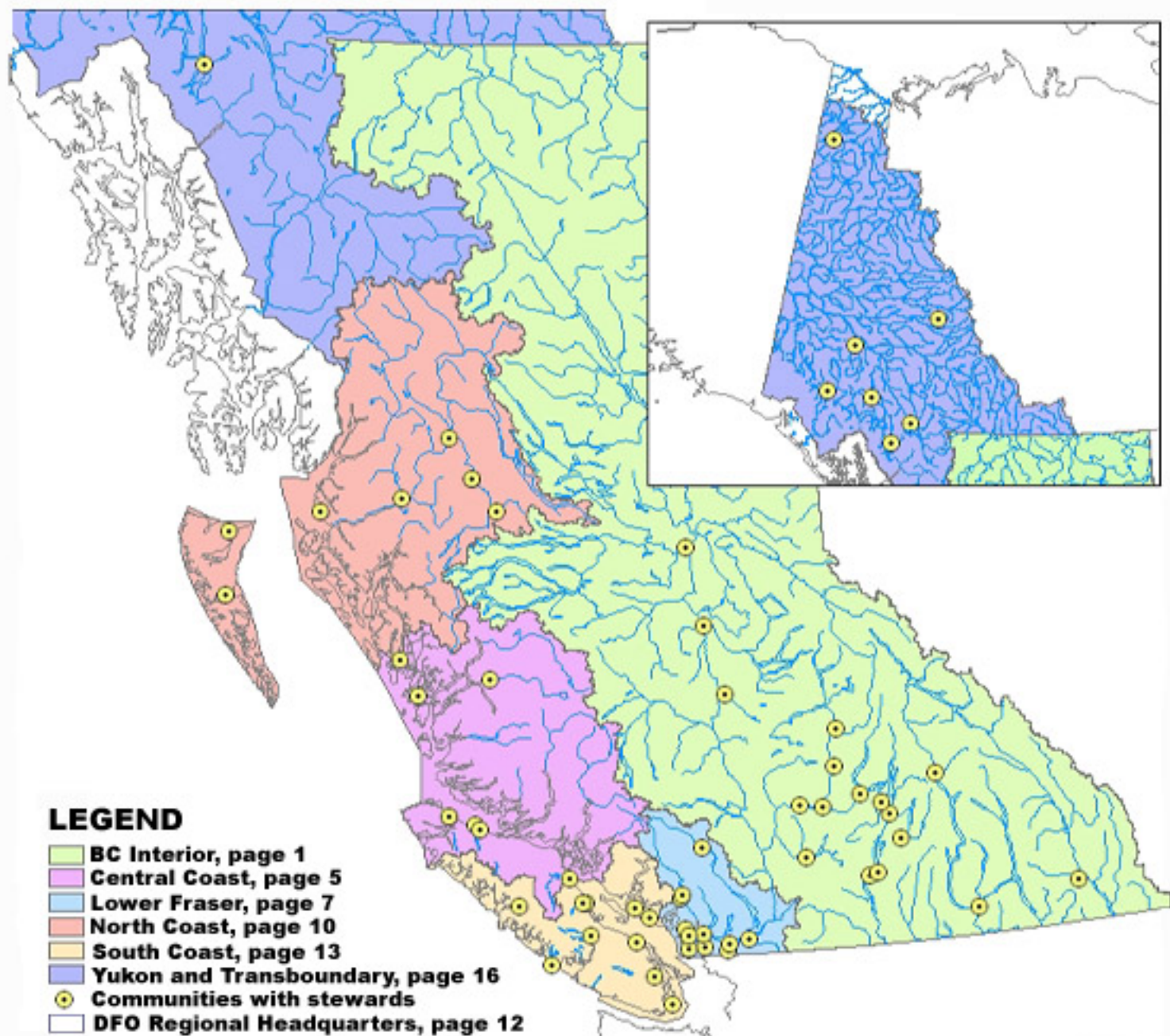
-- **Stewardship Coordinators:** work for non-government organizations. The primary role of the SC is to facilitate and advocate for community fish habitat protection. They will also support restoration and enhancement projects that serve regional/local priorities as a secondary priority.

-- **Habitat Stewards:** are technical field personnel that mainly work for local government agencies. The focus of their efforts will be to anticipate, prevent, and, where necessary, respond to habitat impact events. HS' will provide technical information for improved planning and decision-making, as well as guidance and advice on the application of habitat protection standards, to guidelines and Best Management Practices in the field.

-- **Habitat Auxiliaries:** are technical field personnel that work as DFO employees. The focus of their efforts will be to anticipate, prevent, and, where necessary, respond to habitat impact events. HAS will provide technical information for improved planning and decision-making, as well as guidance and advice on the application of habitat protection standards, to guidelines and Best Management Practices in the field.
