THERE SHALL BE A WATER METER INSTALLED ON THE PREMISES UNLESS EXCUSED THEREFROM BY THE TOWN ADMINISTRATOR. SUCH METER SHALL BE RENTED OR PURCHASED FROM THE TOWN AND ITS INSTALLATION AND LOCATION SHALL BE APPROVED BY THE SUPERINTENDENT OF THE WATER DEPARTMENT OR THE TOWN ADMINISTRATOR. WATER WILL THEN BE PAID FOR AT THE METER RATE, AND IF IT IS NECESSARY TO INSTALL A VAULT FOR THE PROTECTION OF THE METER, THE EXPENSE CAUSED THEREBY, SHALL BE CHARGED AGAINST THE PROPERTY OWNER.

THAT THE TOWN ADMINISTRATOR OR HIS APPOINTED REPRESENTATIVE WILL HAVE ACCESS AT ALL TIMES TO ANY PART OF THE WATER SERVICE. THAT THE SERVICE PIPE FROM THE TOWN MAIN TO THE PROPERTY LINE WILL BE INSTALLED BY THE TOWN OF WOODSTOCK. THAT SERVICE PIPES WILL NOT BE LAID OR PLACED WHEN THE GROUND IS FROZEN UNLESS ANY ADDITIONAL COST OCCASIONED THEREBY IS PAID BY THE PROPERTY OWNER / APPLICANT.

THAT THE SERVICE PIPE FROM THE STREET LINE TO THE PREMISES WILL BE INSTALLED AT PROPERTY OWNER'S OF THE GROUND AND BE AT LEAST 6 FEET (2 METERS) BELOW THE SURFACE OF THE GROUND AND BE EQUIPPED WITH A STOP AND WASTE VALVE IN THE BASEMENT BELOW THE WATER METER. THAT A CHARGE OF \$25.00 IS TO BE MADE BY THE TOWN FOR TURNING ON OR SHUTTING OFF WATER. THAT, FAILING TO PAY MY WATER RATES WITHIN 60 DAYS, THE TOWN IS TO CEASE SUPPLYING ME WITH WATER UNTIL PAYMENT IS MADE IN FULL.

THAT IT IS NOT COMPULSORY FOR THE TOWN TO OPEN THE STREET OR TAKE ANY MEASURE TO THAW OUT WATER AND THAT I TAKE WATER WITH THE UNDERSTANDING THAT THE TOWN WILL NOT IN ANY WAY BE RESPONSIBLE FOR THE STOPPAGE OF WATER BY FREEZING OF THE MAIN SERVICE OR SERVICE PIPE TO THE PREMISES.

THAT I WILL NOT LET WATER RUN IN COLD WEATHER UNLESS APPROVAL IS GIVEN BY THE TOWN ADMINISTRATOR OR APPOINTED REPRESENTATIVE.

THAT WATER MAY BE SHUT OFF FOR THE FOLLOWING REASONS:

- 1. FOR MAKING REPAIRS.
- 2. FOR CONSTRUCTING NEW WORK.
- 3. FOR WASTING WATER.
- 4. FOR NON PAYMENT OF RATES, CONNECTION FEES, OR REPAIR EXPENSES.
- 5. FOR ANY VIOLATION OF THE TOWN BY-LAW.
