ADMINISTRATIVE FRAMEWORK

MANDATE

In co-operation with the school district transportation officers, the Pupil Transportation Branch of the Department of Education is charged with the administration of a safe, efficient and dependable pupil transportation system.

OBJECTIVES

<u>Coordinate</u> the development / revision of administrative policies and the production of support material / documentation in the area of pupil transportation management

<u>Provide</u> and define training requirements for all potential and regular school bus drivers, as well as promote safety and proper conduct on school buses with the collaboration of local school administrations


<u>Assess</u> planning practices (routing and scheduling of school buses) within the various regions of the province and recommend, if necessary, adjustments or new approaches allowing for the optimal use of vehicles, as well as related financial and human resources

<u>Maintain</u> a close link with educational services to ensure that school transportation plays its support services role in the education system; the office of the provincial Registrar for the application of sections of the Motor Vehicle Act that pertains to pupil transportation; the Vehicle Management Agency that looks after the purchase and maintenance of vehicles and; the Commercial Enforcement Branch, Department of Public Safety, which conduct inspections on school buses

<u>Maintain</u> data and pertinent information to determine school districts' budget allocation for school bus operation and to conduct statistical analysis and research.

DEFINITION OF A SCHOOL VEHICLE

BUS *means* any motor vehicle designed for carrying ten or more passengers and used for the transportation of persons.

SCHOOL VEHICLE *means* a motor vehicle operated by a school district or under a conveyance contract for the conveyance of pupils in the public school system and excludes motor vehicles in a public transit system.

SCHOOL BUS *means* a school vehicle that is a bus, is painted national school bus yellow and is equipped with a warning system^{*}.

* WARNING SYSTEM

means a system used to warn motorists that a school bus is stopping for loading or unloading passengers, that consists of amber flashing warning lights, red flashing warning lights and a stop arm.

ELIGIBILITY CRITERIA

•CHILDREN ENROLLED IN PUBLIC SCHOOLS

• STUDENTS RESIDING MORE THAN 2.4 KM FROM SCHOOL

• STUDENTS RESIDING MORE THAT 1.5 KM ON SIDE ROADS

Specific transportation arrangements can be made for special needs students.

Superintendent, with the approval of the District Education Council and within their budget limit, may provide conveyance of pupils within those distances.
