## Minerals and Metals Sector of Natural Resources Canada

The Minerals and Metals Sector (MMS) of Natural Resources Canada is one of five departmental sectors. The others are the Earth Sciences Sector, the Energy Sector, the Canadian Forest Service, and the Corporate Services Sector.

The Minerals and Metals Sector is the federal government's primary source of scientific and technological knowledge and policy advice on Canada's mineral and metal resources, and on explosives regulation and technology. The Sector comprises four branches: Mineral and Metal Policy, Economic and Financial Analysis, Mineral Technology (CANMET), and Planning and Management Services. The Minerals and Metals

Sector devotes a large portion of its resources to science and technology, and houses three of Canada's premier scientific research institutions (the Mining and Mineral Sciences Laboratories, the Materials Technology Laboratory, and the Canadian Explosives Research Laboratory).

**Sustainable development** – The definition of sustainable development in the context of minerals and metals.

**Value added** – Information and publications on issues relating to value added for the Canadian minerals and metals industry.

**Business assistance** – Information, services and programs designed to assist small- and medium-sized Canadian companies with their start-up, growth, funding, networking and other similar activities.

**Trade and exports** – Information, services and programs designed to assist companies that export, or that are interested in exporting, their products, but who lack the necessary expertise or experience in foreign markets.

**Research and development** – Information, services and programs designed to promote research and development activities within Canadian companies.

**Environment** – Information, services and programs designed to encourage the environmental protection and energy conservation initiatives of Canadian companies.

**Aboriginal peoples** – Information, services and programs tailored to meet the specific needs of Canadian Aboriginal businesses.

**The economy and statistics** – Statistics, economic data and a description of services designed to help Canadian businesses better understand their target market and competitors.

**What's new?** – This section describes information sources that can help Canadian companies keep up-to-date on the latest news and developments related to the economy, financing, R&D, the environment, etc.

### **Canada Small Business Financing Program (CSBF)** Industry Canada

The Canada Small Business Financing program (CSBF) is a loan guarantee program that encourages lenders to improve the availability of loans for the purpose of financing the purchase or improvement of real property for the expansion of operations or establishment of a new business. Administered under the *Canada Small Business Financing Act* (CSBFA), the program is a joint initiative of the Canadian government and private sector lenders. Most small businesses (with the exception of farming enterprises) starting up or operating in Canada are eligible for CSBF loans, as long as their estimated annual gross revenues do not exceed \$5 million during the fiscal year in which they apply for a loan. The maximum value of loans a borrower may have outstanding under the CSBF cannot exceed \$250 000.

- I) The MARG program (Master Accounts Receivable Guarantee) is designed to increase the part of your operating lines of credit from your bank that is secured by your foreign accounts receivable.
- II) Other bank guarantees also exist. EDC and the bank share in the risk on medium-term export financing bank loans to foreign buyers of Canadian products and services.

**§ Program for Export Market Development (PEMD)**  
Team Canada Inc

The objective of the PEMD is to increase export sales of Canadian goods and services by sharing the costs of activities that companies normally could not or would not undertake alone. Preference will be given to companies with annual sales greater than \$250 000 and less than \$10 million, and with less than 100 employees in the case of firms in the manufacturing sector and 50 in the case of those in the service industry.

**Market Development Strategies (MDS):**

The MDS provides assistance for various international marketing activities. Contributions range from \$5000 to \$50 000 and repayment is based on 4% of incremental sales made in the specified target market. Eligible costs include product testing for market certification, legal fees for marketing agreements abroad, transportation expenses to Canada for offshore company trainees, and product demonstration costs and other expenses related to the implementation of the marketing plan.

**New-to-Exporting:**

This element of the PEMD targets companies that have no export experience and lack a capability to export or to develop an international marketing plan. A maximum (repayable) contribution of \$7500 is available to such companies either for a market identification visit, or for participation in an international trade fair.

The PPP enables Canadian businesses to free up the working capital they need on export sales. Once CCC backs a deal, the participating bank will provide funds for the export sale, beyond the company's normal line of credit. Once this line of credit is in place, CCC verifies work done for the contract, and the company can access progress payments accordingly. The program is available to all firms with sales of \$50 million or less, and credit lines are limited to \$2 million per transaction.

## **§ Industrial Research Assistance Program (IRAP) National Research Council of Canada (NRC)**

IRAP's financial assistance provides SMEs with a complete service package that enables them to validate and develop innovative ideas. By offering sources of financing for strategic research and development activities, IRAP helps SMEs to create employment and acquire necessary services.

**For small-scale projects**, IRAP may fund up to 50% of development costs in certain cases. A maximum of \$15 000 in funding is available for small-scale projects.

**For projects on a larger scale** and more complex, long-term projects, IRAP may fund up to 50% of development costs. This assistance is normally applied toward salary costs. Funding for these larger-scale projects can range from \$5000 to \$350 000 for a period exceeding 36 months.

IRAP, Technology Partnerships Canada, NRC and Industry Canada have joined forces to support innovative SMEs by delivering financial assistance **for projects in the precommercialization stage**. This IRAP-Technology Partnership Canada initiative provides SMEs with direct access to repayable financial assistance in support of precommercialization activities.

Once the CIPEC task forces have drafted targets and action plans, the Industrial Energy Innovators Initiative provides a means of turning sector commitments into company actions. Projects begin with CEOs and other senior officials committing to implement energy-saving measures in their organizations. When this commitment has been assured, the Industrial Energy Innovators Initiative provides the information and support services necessary to start and implement an upgrade.
