



MALIOTENAM

DESCRIPTION

The Maliotenam Reserve includes the south half of lot 5, as well as lots 6 (part), 7 (part), 8-2, 8-4 and 8 (part), all in the Range 1, cadastre of the township of Letellier.

It covers 527 hectares.

LOCATION

The Maliotenam Reserve is located 16 kilometres east of Sept Îles.

LAND TITLE HISTORY

April 27, 1947 - REGISTRATION NUMBER 6066-191

Resolution of the Band Council of Sept Îles and Moisie to ask for government help due to the lack of lands available for settlement.

August 26, 1947 - REGISTRATION NUMBER 6067-191

Order of Privy Council 1947-3451 authorizing the purchase of south half of lot 5, and of lot 6, 7 and 8, Range 1, township of Letellier.

January 27, 1948 - REGISTRATION NUMBER 6068-191

The Government of Canada purchases from Wilfrid-Eugène Gallienne, merchant, lots 6, 7, 8 and the true half of lot 5, all of Range 1 of the township of Letellier.

April 12, 1949 - REGISTRATION NUMBER 6069-191

Government of Canada Order in Council 1949-1793 to set aside, for the benefit and usage of the Indians, the lots purchased in 1948.

February 25, 1960 - REGISTRATION NUMBER 6076-191

Government of Canada Order in Council 1960-214 transferring to the Government of Québec the control and administration of a portion of part of lots 6, 7 and 8, Range 1, township of Letellier, for the construction of Provincial Highway 15. The area indicated is 9.47 hectares (20.95 acres). See CLSR plan 5261.

March 16, 1973

Correction of the northeast and east boundaries of the south half of lot 5, Range 1, township of Letellier, to ensure conformity with the acquisition title of Her Majesty. See CLSR plan 58 204.

May 31, 1979 - REGISTRATION NUMBER 65016

Band Council Resolution requiring to change the name from Sept Îles Number 27A to Maliotenam Number 27A.

February 1, 1984 - REGISTRATION NUMBER 99468

Québec Government Order accepting a land exchange with the Government of Canada. Québec, in return for the amount of \$1 500 and the surrender of lots 8-2 and 8-4 of Range 1, township of Letellier (0.33 hectare), will be transferred lots 7-1, 8-1 and 8-3, all of Range 1 of the township of Letellier (3.28 hectares).

October 24, 1985 - REGISTRATION NUMBER 104285

Government of Canada Order in Council 1985-3193 surrendering to the Government of Québec the control and administration of lots 7-1, 8-1 and 8-3, Range 1, township of Letellier, for road purposes in exchange for lots 8-2 and 8-4, Range 1, township of Letellier. See CLSR plan 68 181.

CHRONOLOGY OF BOUNDARY SURVEYS

- 1) **1949**: survey of the outer boundaries by Roland Samson;
- 2) **1973**: resurvey of the northeast boundary and survey of the east boundary of the south half of lot 5 by Rodrigue Tremblay;
- 3) **1974**: resurvey of north and west outer boundaries, i.e. of lots 6, 7 and 8, by Rodrigue Tremblay;
- 4) **1991**: clearing of the reserve's outer boundaries by a team from the band, wooden posts replacement and densification of the boundary blazes.
