



SENIORS CRIME STOPPERS

It is estimated that by the year 2020, there will be as many senior citizens in Ontario as there are youth. The dramatic growth of our senior's population is unparalleled at any previous time in our history. Increasingly, our senior's are more frequently victims of crime. In order to address this problem, the Ontario Association of Crime Stoppers has partnered with the Ministry of Community Safety and Correctional Services in developing a Seniors Crime Stoppers program.



Background

In the early spring of 2005, the OACS received funding towards a province-wide **Seniors Crime Stoppers** program. Renegade Digital Productions, Inc. are working with the OACS in the development of comprehensive seniors targeted training materials which will enable Crime Stoppers personnel to attend seniors facilities and present both the Crime Stoppers story and some of the criminal activity impacting our seniors population.

Further application has been made to the Ontario Trillium Foundation for suitable funding to purchase handout materials for these presentations that will target Ontario seniors

The Ministry of Health and Long Term Care oversees the operation of 619 seniors' facilities in the province. In addition, there are approximately 700 private retirement homes of which 300 are members of the Ontario Retirement Communities Association (ORCA).

The Retirement Home Complaints Response and Information Service assists consumers by addressing their concerns about Ontario retirement homes – whether they are a member of ORCA or not.

Victimization

The Seniors Crime Stoppers initiative addresses situations where seniors are being victimized by the criminal acts of others. This criminal activity is typically broken down into four sub-groups, namely: physical abuse, psychological or emotional abuse, financial abuse or neglect.
