

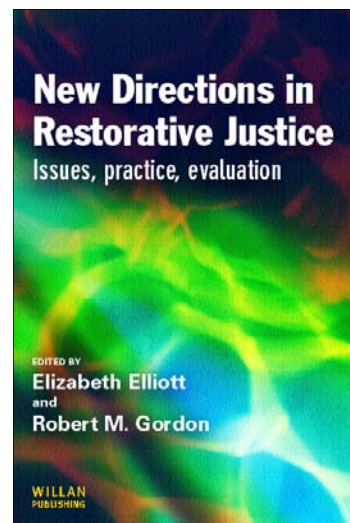
## ***New books on Restorative Justice from Willan Publishing***

### **New Directions in Restorative Justice: issues, practice, evaluation**

Edited by **Elizabeth Elliott** and **Robert Gordon** (Centre for Restorative Justice, Simon Fraser University)

In the past 30 years, the beliefs and practices that together have become known as 'restorative justice' have re-energised the research and policy dialogues in the fields of criminology and public policy. Restorative Justice is found in practices as diverse as criminal justice system diversion programmes and other alternative measures, and in conflict resolution strategies addressing both school discipline issues and changes in school culture aimed at reducing conflict

This book addresses a number of key themes and developments in restorative justice, and is based on papers originally presented at the 6th International Conference on Restorative Justice in Vancouver. It is concerned with several new areas of practice within restorative justice, with sections on restorative justice and youth, aboriginal justice and restorative justice, victimization and restorative justice, and evaluating restorative justice. Contributors to the book are drawn from leading experts in the field from the UK, US, Europe, Canada, Australia and New Zealand.

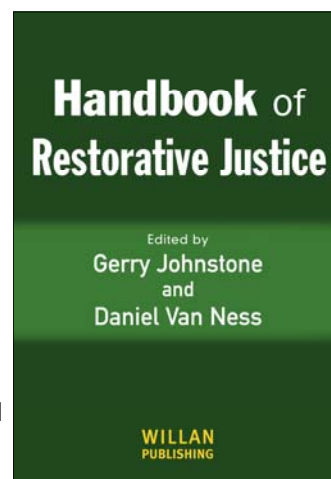
## Handbook of Restorative Justice

This book provides a comprehensive and authoritative account and analysis of restorative justice, one of the most rapidly growing phenomena in the field of criminology and justice studies.
