Optional field to record your own file number as a reference. Maximum of 20 characters.

Page ____ of ____

Complete even when only one page is required to capture relevant data, e.g. Page 1 of 1.

Type of change

Determine the type of change and enter an "X" in the category box describing the change. Follow the instructions below for the selected category. Only one category can be selected per change statement.

Record to be changed

Enter the registration number and page number of the Financing Statement to be changed. If changing a previously registered Financing Basic Statement, enter the name of the first debtor exactly as it appears on that statement. If a previously registered Financing Change Statement is to be changed, enter the name of the debtor appearing in the "record to be changed" section of that statement. Note: The computer will compare the registration number and debtor name to the financing statement being changed. If there is any inconsistency whatsoever, the financing change statement will be rejected. The registration will then have to be resubmitted on a new financing change statement form. The date of registration will be the date that the properly prepared financing statement is received.

General instructions for deletions section

When a debtor is to be discharged or secured party is to release their interest, enter the name of the party in the deletions section exactly as it appears on the financing statement being changed.

General instructions for additions section

When a debtor or secured party is to be added, enter the full name and address of the party on the appropriate lines in the additions section.

For debtors, enter an "X" to indicate whether the name is that of an individual or business. For individual debtors, enter a birth date as year, first three letters of month, and day, e.g. 53 OCT 19. For secured parties, the secured party code may be entered instead of name and address, if one has been assigned.

General instructions for changes

When any secured party or debtor information needs to be changed, the party must be deleted and then added again, as described above.

Specific instructions

Renewal: Enter a period from 1 to 25 years as the renewal life, which will be effective from the date of renewal. The renewal must be registered prior to expiry of the registration. Do not complete the deletions or additions section.

Total discharge: Do not complete the deletions or additions section.

Debtor release: Delete the name of the debtor or debtors to be released.

Assignment by secured party or transfer by debtor: Delete the name of the party or parties assigning their interest and add the new party or parties, if any.

Name/address change or correction of error: Delete any parties recorded incorrectly and add correct information.

Court order or other change: Both a Financing Change Statement A and B will be required. See the special note on the back of the Financing Statement B form.

Registrant

Enter the name and address of the registrant or the registrant code if one has been assigned. The verification statement will be mailed to the registrant.

Authorized signature of secured party

This form must be signed by the secured party or parties or a person with actual, implied or apparent authority to sign on behalf of the secured party or parties.
