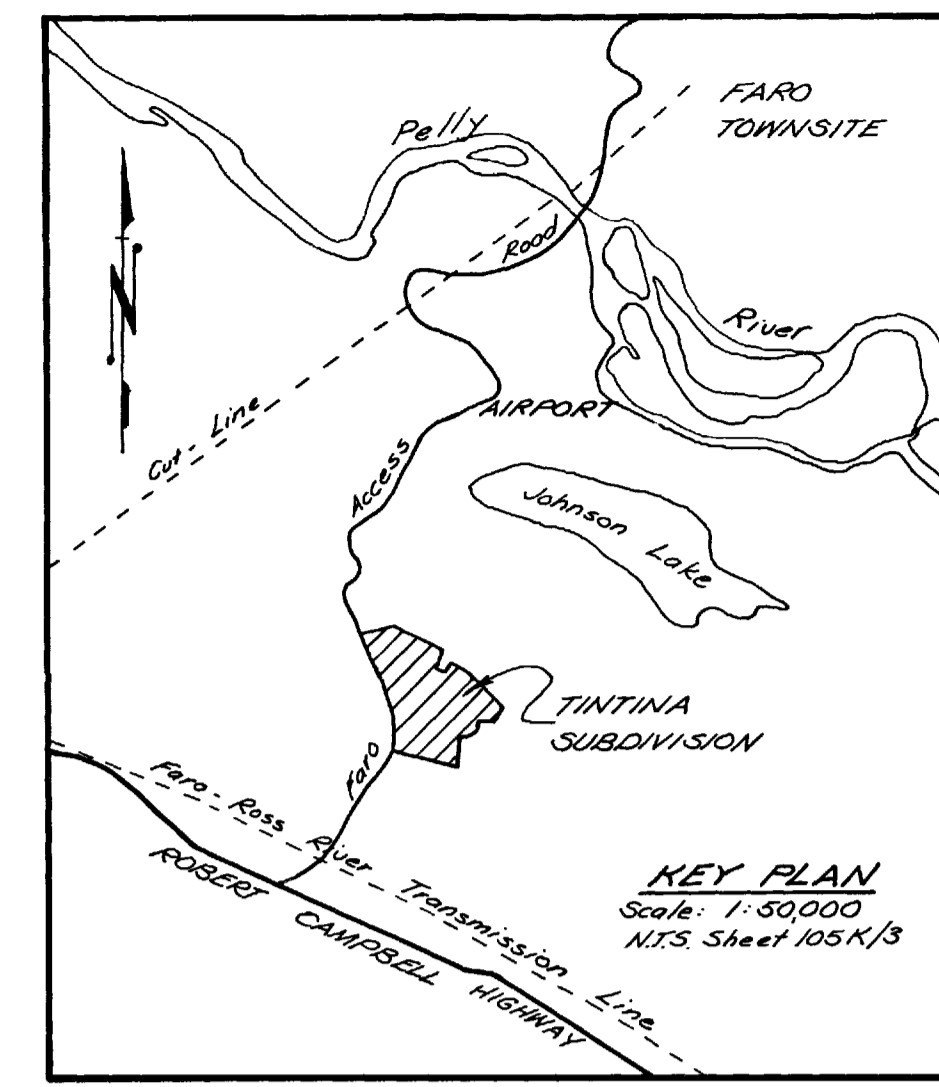


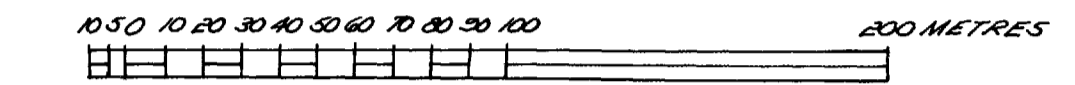

YUKON TERRITORY**

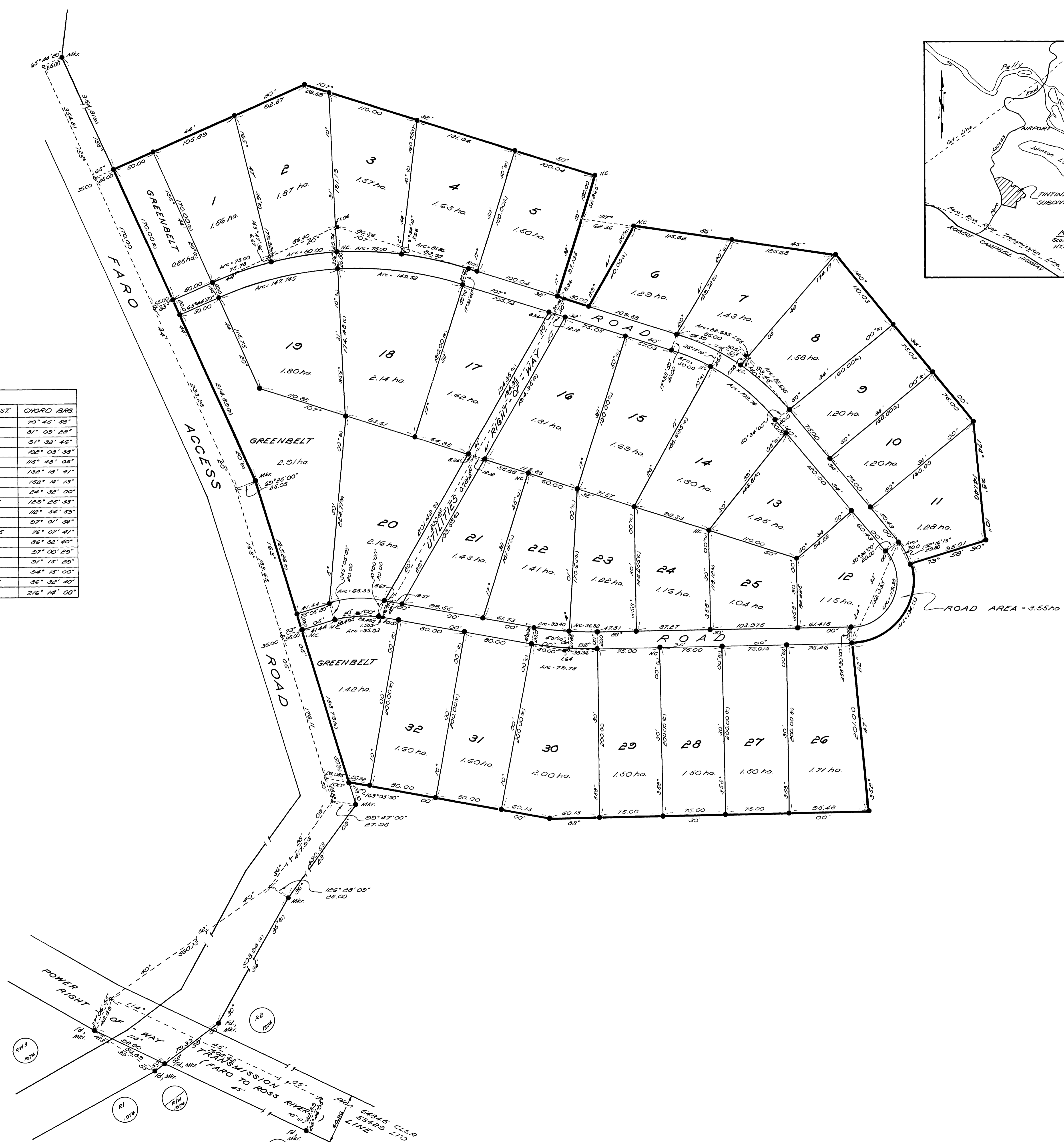
