

# INSTRUCTION SHEET FOR COMPLETION OF A CLASS II NOTIFICATION

## *Placer Mining Land Use Regulation Schedule I*

The Mining Land Use Office needs to know who you are and how to get in touch with you while processing your Notification. In case you should be unavailable, you must provide us with a contact person or persons who will be able to get messages to you in a relatively short time frame.

NAME	Enter the name of a company or an individual.
SUMMER ADDRESS	Enter the mailing address at which you can be reached during the summer season.
WINTER ADDRESS	Enter the mailing address at which you can be reached during the off season, if different than the summer address.
TELEPHONE/ FAX/ E-MAIL	Enter the numbers at which you can be reached during the approval process.
NAME OF CONTACT/ TELEPHONE	Provide a name and telephone number of a contact, if you are going to be unavailable at any time.
NAME OF ALTERNATE CONTACT/ TELEPHONE	If your contact will not be available on a regular basis, provide an alternate contact name and telephone number.

The following information blocks are designed to identify exactly where you are planning to undertake your proposed program, claim ownership, and the duration of your program.

PROPOSED PROGRAM LOCATION (attached map)	<p>INCLUDE QUADRANT (NE, NW, SE, SW) WHEN IDENTIFYING MAP NUMBER (i.e. 105C/03 for 1:50,000 scale)</p> <p>Attach a map at 1:50,000 scale (or more detailed) to your application which shows the location of your claims and the areas where the proposed activities will take place. The map must also show the location of streams and other topographic features, as well as any existing structures, clearings, or any other works, etc. which may be affected by the land use activity.</p> <p><b>Consider using a topographic or claim map as your base map.</b></p>
CLAIM NAMES, NUMBERS AND CLAIM SHEET	Describe your claims including all of the required information listed on the left column. This information may be attached.
PROPOSED START DATE	Enter the date on which you intend to start the proposed activities.
PROPOSED END DATE	<p>Enter the date on which you intend to end the proposed activities.</p> <p><b>CLASS II PROGRAMS ARE A MAXIMUM OF ONE YEAR, INCLUDING RECLAMATION WORK.</b></p>

### PROPOSED ACTIVITIES

The following criteria represent the elements outlined in section 4 of the *Regulations*. Please check the table on the following page to ensure that the level of activities you are proposing do not exceed the thresholds which define a Class II operation.

SIZE OF CAMP	Enter the maximum number of persons who will be at the camp at any one time.
NUMBER OF DAYS PLANNED OCCUPANCY	Enter the number of days the proposed field camp will be occupied, including the number of people if they change through the course of the program.
TYPE OF STRUCTURES	Describe the type of structures which you plan to erect on your claims for the purpose of undertaking the exploration program. <b>Remember that only structures with temporary foundations are allowed, and must be removed within the 12 month period of operation.</b>
FUEL REQUIREMENTS	Enter the quantity of fuel you will require for the exploration program. Note the amount of fuel you will be storing at any one time.
FUEL STORAGE METHODS	Describe the fuel storage containers you plan to use at the proposed exploration site. <b>Indicate secondary containment methods where containers are over 4,000L.</b>
DIMENSION OF LINES OR CORRIDORS	Enter the proposed width and total length of any lines or corridors planned. Indicate if they are lines or corridors.
DIMENSION OF OVERBURDEN PILES	Enter the proposed height, width and length of any planned overburden piles.
TOTAL TRENCHING	Enter the number of trenches and the dimensions or volume (length x width x height) of each of the proposed trenches.
NUMBER AND SIZE OF STRIPPING SITES PROPOSED PER CLAIM	Enter the number of stripping sites proposed and the area of each site (length x width).
PURPOSE OF STRIPPING	Enter the reason for making the clearing and if the vegetative mat is to be removed or not.
AMOUNT OF DITCHING/ DRAINS PER CLAIM	Enter the volume of proposed ditches or drains (length x width x depth)
TYPE OF VEHICLES TO BE USED FOR PROPOSED ACTIVITY	List the types of equipment and vehicles you will be using so we may determine the weight. Enter the weight of the vehicle if known.
<i>LENGTH AND APPROXIMATE LOCATION OF:</i>	<b>Remember to show the location of roads or trails on the LOCATION MAP.</b>
1. NEW ACCESS ROADS OR TRAILS CONSTRUCTED	Enter the dimensions of any new roads or trails you are proposing to construct including both length and width. Indicate if it is a road or trail according to the definitions in the regulations.
2. ROADS OR TRAILS UPGRADED	Enter the total length of any roads or trails you are proposing to upgrade. Indicate if it is a road or trail according to the definitions in the regulations.
3. OFF ROAD TRAILS USED BY VEHICLES	Enter the total distance which you plan to travel on the proposed trail, and the number of times you propose to travel.
DESCRIPTION OF UNDERGROUND WORK	Specify the dimensions of proposed underground work, the amount of material being moved to the surface and the manner in which the construction will be carried out.
AMOUNT OF EXPLOSIVE TO BE USED	Describe the amount of explosives you will be using within each consecutive 30 day period.
OPERATING PROCEDURES	Describe how you plan to carry out your work program including reclamation. Minimal environmental standards are outlined in the <i>Operating Conditions</i> in Schedule I of the <i>Regulations</i> . Further examples can be found in the <i>Handbook of Reclamation Techniques for Mineral Exploration in the Yukon</i> .
