

ANNEX CODES

This section describes special provisions that apply to certain products in the EICB Import Control Schedule. The provisions are indicated by a four digit code and replace the default code "0000" when applying for a permit.

<u>ANNEX CODE</u>	<u>DESCRIPTION</u>
0032	Special woven fabrics, tufted textile fabrics, lace, tapestries, trimmings and embroidery of Chapter 58 and knitted or crocheted fabrics of Chapter 60, of cotton and/or man-made fibres. This code applies only to imports from Mexico and the United States under NAFTA, of non-originating goods, and from Chile, under the Canada/Chile Free Trade Agreement, of non-originating goods, and from Costa Rica, under the Canada/Costa Rica Free Trade Agreement.
0036	Cotton or man-made fibre fabric of headings 52.12, 54.07, 54.08, 55.15 and 55.16 containing 36% or more by weight of wool or fine animal hair. This code applies only to imports from Mexico under NAFTA (Refer to NAFTA, Annex 300-B, Appendix 6), and from Chile under the Canada/Chile Free Trade Agreement, and from Costa Rica, under the Canada/Costa Rica Free Trade Agreement.
0414	<p>(a) Tapestry fabrics and upholstery fabrics of wool or fine animal hair - U.S. textile category 414, other wool fabrics:</p> <ul style="list-style-type: none"> - of a weight not exceeding 140 g/m² classifiable under HS heading 51.11 and 51.12; - of a weight exceeding 300 g/ m² classifiable under HS heading 51.11 and subheadings 51.12.20 through 51.12.90; - of a weight exceeding 200 g/ m² classifiable under HS subheading 5112.19; excluding tapestry and upholstery fabrics containing 30% or more by weight of silk or silk waste, valued at \$33US/kg classifiable under HS subheadings 5111.90 and 5112.90, and <p>(b) Other certain wool or fine animal hair textile products of U.S. category 414 of Chapters 58 and 60.</p>

1213	Worn clothing and other worn articles of heading 63.09 of cotton or man-made fibres. This code applies only to imports from Mexico under NAFTA, Chile under CCFTA, and Costa Rica under the CCRFTA.
2336	Knitted or crocheted products of Chapter 61, of man-made fibres containing 23% or more by weight of wool or fine animal hair, and woven products of Chapter 62, of man-made fibres containing 36% or more by weight of wool or fine animal hair. This code applies only to imports from Mexico and the United States under NAFTA, Chile under CCFTA, and Costa Rica under the CCRFTA.
6301	Bath towels of subheading 6302.91, of cotton or man-made fibres. This code applies only to imports from Mexico under NAFTA, Chile under CCFTA, and Costa Rica under the CCRFTA.
