## **Yukon Ethics and Accountability Act**

#### **Preamble**

Recognizing that accountability to the public is an important element of governing; and

Recognizing that the public expects their government to adhere to the highest ethical standards possible;

The Commissioner of Yukon, by and with the advice and consent of the Legislative Assembly, enacts as follows:

# **Accountability and Operational Plans**

**1** Ministers shall table annually accountability and operational plans with the main estimates presented to the Legislative Assembly by the Government for the fiscal year,

### Financial Administration Act amended

- 2 (1) This section amends the Financial Administration Act.
- **2 (2)** The *Financial Administration Act* is amended by adding the following section immediately after section 3.
  - "3.1(1) No Minister shall be appointed or remain appointed as a member or an alternate member of the management board at such time as
    - (a) the Minister,
    - (b) any sole proprietorship or partnership of which the Minister is a proprietor or partner, or
    - (c) any corporation controlled directly or indirectly by the Minister

is in arrears on any amount owed to the government."

- **2 (3)** Section 14 of the Act is amended by adding the following subsection immediately after subsection 3
  - "14(3.1) This section does not apply to any part of a debt or obligation owed to the government by
    - (a) a Minister,
    - (b) any sole proprietorship or partnership of which a Minister is a proprietor or partner, or
    - (c) any corporation controlled directly or indirectly by a Minister."

#### Conflict of Interest Act amended

- **3 (1)** This section amends the Conflict of Interest Act.
- **3 (2)** Subsection 3(1) of the *Conflict of Interest Act* is amended by adding the following paragraph

- "3(1)(d) is in arrears on any amount owed to the government."
- **3 (3)** Section 3 of the Act is amended by adding the following subsections
- "3(2.1) The term "Member or Minister" where it appears in paragraph 3(1)(d) of this Act includes (a) any sole proprietorship or partnership of which the Member or Minister is a proprietor or partner, and
- (b) any corporation controlled directly or indirectly by one or more of the Member or Minister."
- (2.2) The term "government" where it appears in paragraph 3(1)(d) of this Act has the same meaning as it has in the *Financial Administration Act*."

#### Elections Act amended

- 4 (1) This section amends the Elections Act.
- **4 (2)** Section 110 of the *Elections Act* is amended by adding the following subsection
- "(3) No person shall be nominated as a candidate if they have been convicted of a corrupt or illegal practice under any section of this act."

# Access to Information and Protection of Privacy Act amended

- 5 (1) This section amends the Access to Information and Protection of Privacy Act.
- **5 (2)** The Access to Information and Protection of Privacy Act is amended by adding the following section immediately after 47 1 c)
- "47 1 d) There shall be an annual reporting process, by the Ministry responsible, on the administration of this Act."

# **Coming into Force**

6 This Act comes into force on a day to be fixed by the Commissioner in Executive Council.
