**Re: Extension of time to begin operating the Corus Entertainment Inc./On-Demand Inc.
Video-on-Demand service licensed pursuant to Decision CRTC 2000-734**

Pursuant to Decision CRTC 2000-734, the Canadian Radio-television and Telecommunications Commission (the "Commission") granted a licence for a new video-on-demand service (the "VOD service") to a joint venture involving Corus Entertainment Inc. ("Corus") and On-Demand Inc., on behalf of a company to be incorporated.

In the licensing decision, the Commission stated that the licence would only be effective if the service begins operating within 12 months of the date of the decision or applies for an extension. Pursuant to Decision CRTC 2002-34 and CRTC Decision 2004-53, the Commission granted extensions to launch the service.

We have investigated what technology is available to launch a VOD service, and are currently in advanced discussions with an affiliate to consider distribution arrangements that may be appropriate for the launch of our VOD service. Consequently, Corus respectfully requests that the Commission extend the deadline to implement the Corus VOD service for an additional 12 months, to December 14, 2005. Given the relative newness of this platform, its technical challenges, and the arrangements we must make such as reviewing of rights agreements, we consider that this extension is appropriate.
