

CFCR will continue to foster and promote the development of local and other Canadian talent through the following means:

Live Performance Broadcasting – We will carry on the practice of regularly scheduled broadcasts by local and touring Canadian artists. Our coverage of local arts and music festivals will likewise continue.

Concert Promotion – Our station remains committed to the practice of producing concerts by local and touring Canadian acts, having successfully promoted numerous such events over the past number of years in Saskatoon.

Radio Programming - CFCR has always made its airwayes available for interviews with touring Canadian musicians, writers and comedians. Furthermore, our program schedule includes shows devoted to local and regional talent on a weekly basis.

Question 3.3

Through on-air announcements and networking on the part of our volunteers, members of the general public are encouraged to become involved in the Community Radio Society of Saskatoon. Those individuals wishing to participate in our on-air programming are required to complete a Program Proposal form, which is then reviewed by our Programming Committee. Successful candidates are given the appropriate broadcast training by our Program Director and receive a Volunteer Manual which outlines operating procedures and the expected quality broadcast standards. Our Programming Committee, which meets on a monthly basis, conducts regular program reviews.
