#### 3.1 CULTURAL DIVERSITY

The Commercial Radio Policy (1998-41) "encourages broadcasters to reflect the cultural diversity of Canada in their programming and employment practices, especially with respect to news, music and promotion of Canadian artists."

Recognizing that the means to address issues related to cultural diversity in radio will be highly dependent on a station's particular format, describe measures you have taken, as well as those you will be taking, to incorporate and reflect the reality of Canada's cultural, ethnic, racial and Aboriginal diversity, in the following areas:

- 1. EMPLOYMENT PRACTICES Our hiring policy is simple the best person gets the job. We have hired an African Canadian, we have had Aboriginal volunteers and 4 of our 11 fulltime staff are women. Three of these women are in Managerial positions.
- NEWS We cover all major stories, regardless of culture or race and they are portrayed in a manner that reflects our community. Locally, our newsroom is on the mailing list with the Native Friendship Centre in Barrie.
- 3. MUSIC Women is one of the minority groups identified and 30% of our music, features women bands or singers. Out of Eden and Michael Tait are probably the best known black artists that we play regularly. We also play hispanic artists Jaci Valesquez and the Katinas.
- 4. PROMOTION OF CANADIAN ARTISTS We are eager to find Canadian music that fits the sound of our station. Bevacqua, Hawk Nelson, Thousand Foot Krutch, Starfield, Carried Away, Matt Brouwer and Greg Sczebel are the most prominent Canadian performers. We partner with Kingdom Bound in an annual talent search with on air promotion requesting audition tapes. The qualifiers are showcased in the semi-finals in both Barrie and Peterborough. This summer we plan another talent search called "Karoke Superstar" showcased in five local cities and the winner receives studio recording time and cd distribution to every Christian radio station in

Canada. This is open to residents within the CJLF service area.
